A RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF KELLER, TEXAS, APPROVING AN AGREEMENT FOR ARTIST SERVCIES AND ORIGINAL ARTWORK WITH SHE DRAWS ON WALLS OF FORT WORTH, TEXAS, FOR THE PURPOSE OF PROVIDING THE INSTALLATION OF EIGHT MURALS FOR THE KELLER SPORTS PARK; IN AN AMOUNT NOT TO EXCEED \$42,240.00; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL CONTRACT DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

- WHEREAS, it has been determined by the City Council of the City of Keller, Texas that it is in the best interest of the health, safety and general welfare of the citizens of the City of Keller to install eight sports nostalgia themed murals at the Keller Sports Park; and
- WHEREAS, a subcommittee of members of the Public Arts Board and the Parks and Recreation Advisory Board conducted a call for artists competition and reviewed proposals from thirty five (35) artists for the project; and
- WHEREAS, the subcommittee considered the proposals at their May 22, 2025 meeting and unanimously voted to recommend approval of She Draws on Walls, consisting of Amy Brines Jimmy Joe Jenkins; and
- WHEREAS, She Draws on Walls of Fort Worth, Texas is hereby recommended to installed said eight murals, in the amount of \$42,240.00, for the City of Keller Sports Park Mural Project; in accordance with the terms and conditions set forth in the agreement for Artist Services and Original Artwork, attached hereto as Exhibit "A".

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: THAT, the City Council of the City of Keller, Texas hereby approves a contract agreement for Artist Services and Original Artwork with She Draws on Walls of Fort Worth, Texas, for the purpose of providing the installation of eight sports nostalgia themed murals at the Keller Sports Park; and further authorizes the City Manager to execute said Agreement relating thereto on behalf of the City of Keller, Texas.
- Section 3: THAT, the cost of said Agreement for Artist Services and Original Artwork shall be paid from the Keller Development Corporation Fund.
