A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPOINTING CITY COUNCIL MEMBER(S) TO SERVE ON VARIOUS BOARDS AND COMMITTEES; AND APPOINTING A MAYOR PRO TEM.
