## ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING A SPECIFC USE PERMIT (SUP) FOR SACRED GROUND THERAPY, A MENTAL HEALTH PRACTICE PROPOSED IN A 985 SQUARE-FOOT LEASE SPACE IN AN EXISTING 23,000 SQUARE-FOOT BUILDING ON 1.91 ACRES, AT THE INTERSECTION OF KELLER PARKWAY AND COUNTRY BROOK DRIVE, LEGALLY DESCRIBED AS LOT 2, BLOCK B OF THE KELLER TOWN CENTER ADDITION, ZONED TOWN CENTER (TC) AND ADDRESSED 1240 KELLER PARKWAY, SUITE 205, IN THE CITY OF KELLER, TARRANT COUNTY, TEXAS; PROVIDING A PENALTY; AND AUTHORIZING PUBLICATION.

WHEREAS, Jonathan Marcotte, Applicant, and David Washington, Owner, have submitted a Specific Use Permit (SUP) application to operate a mental health practice in the Town Center Zoning District (SUP-24-0012); and

WHEREAS an SUP is required for all medical offices in the Town Center Zoning District; and

WHEREAS, the City's Planning and Zoning Commission and the City Council, in accordance with the Charter of the City of Keller, State Law, and the ordinances of the City of Keller, have given the required notices and have held the required public hearings regarding the SUP application described in this ordinance; and

WHEREAS, the City Council is of the opinion the SUP request herein effectuated furthers the purpose of zoning as set forth in the Unified Development Code and is in the best interest of the citizens of the City of Keller;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, in accordance with the Unified Development Code, the City Council of the City of Keller, Texas hereby authorizes approval of a Specific Use Permit (SUP) for Sacred Ground Therapy, a mental health practice proposed in a 985 square-foot lease space in an existing 23,000 square-foot building on 1.91 acres, at the intersection of Keller Parkway and Country Brook Drive, legally described as Lot 2, Block B of the Keller Town Center Addition, zoned Town Center (TC) and addressed 1240 Keller Parkway, Suite 205.

Section 3: THAT, any person, firm, or corporation violating any of the provisions of this Ordinance, as read together with the Unified Development Code and

accompanying map thereto, shall be guilty of a misdemeanor and upon final conviction therefore shall be fined in a sum not to exceed Two Thousand Dollars (\$2,000.00). Each and every day such violation continues shall constitute a separate offense and shall be punishable as such hereunder.
