A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE BID FROM CORE & MAIN, LP OF RICHLAND HILLS, TEXAS, IN THE AMOUNT OF \$224,382.33, FOR THE PURCHASE OF WATER AND SEWER LINE PARTS, FOR THE WATER AND WASTEWATER DIVISION OF THE PUBLIC WORKS DEPARTMENT; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL PURCHASE DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, a request for sealed bids for the purchase of water and sewer line parts, for the Water and Wastewater Division of the Public Works Department was duly advertised in accordance with State law, and said bids were received, opened, and read aloud at 1:00 p.m., on September 17, 2025; and

WHEREAS, Core and Main, LP of Richland Hills, Texas was the sole qualifying respondent to the bid advertisement, with two (2) vendors indicating a No Bid response; and

WHEREAS, the Fiscal Year 2025-26 Annual Budget provides for the purchase of water and sewer line parts, for the Water and Wastewater Division of the Public Works Department; and

WHEREAS, the proposed agreement shall last one (1) year with the option to automatically extend said agreement for an additional four (4) one (1) year periods; and

WHEREAS, funding for additional one (1) year periods is contingent upon budget approval by the City Council for water and sewer parts.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby approves the bid from Core & Main, LP, of Richland Hills, Texas in the amount of \$224,382.33, for the purchase of water and sewer line parts, for the Water and Wastewater Division of the Public Works Department; and further authorizes the City Manager to execute all purchase documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cumulative cost of water and sewer line parts for the fiscal years ended September 30, 2026 through September 30, 2028 shall not exceed \$742,321.16.
