

RESOLUTION NO. 4467

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE PURCHASE OF POOL DECK REPLACEMENT AND TILE CLEANING SERVICES FOR THE INDOOR POOL, FOR THE KELLER POINTE RECREATION AND AQUATIC CENTER, IN THE TOTAL AMOUNT OF \$479,669.00; FROM SUNBELT POOLS, INC. OF DALLAS, TEXAS, THROUGH THE BUY BOARD PURCHASING PROGRAM; AND CANCELLING THE AGREEMENT APPROVED BY RESOLUTION NUMBER 4421 ON OCTOBER 5, 2021 WITH SUNBELT POOLS, INC. EFFECTIVE JANUARY 18, 2022; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL PURCHASE DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, the City Council of the City of Keller, Texas, has deemed it necessary and in the best interest of the citizens of the City of Keller to replace the existing indoor pool decking and to clean the indoor pool tile at The Keller Pointe Recreation and Aquatic Center; and

WHEREAS, the purchase will be funded by The Keller Pointe fund and require a future budget amendment; and

WHEREAS, the purchase from Sunbelt Pools, Inc., of Dallas, Texas, through the Buy Board Purchasing program has been determined to be the lowest and most responsible method of purchasing therefor.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby approves the purchase of indoor pool deck replacement and indoor pool tile cleaning services, in the total amount of \$479,669.00, for The Keller Pointe Recreation and Aquatic Center, from Sunbelt Pools, Inc., of Dallas, Texas through the Buy Board Purchasing program; and cancels the agreement by Resolution Number 4421 on October 5, 2021 with Sunbelt Pools, Inc. effective January 18, 2022 and; and further authorizes the City Manager to execute all purchase documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of said purchase of indoor pool deck resurfacing and indoor pool tile cleaning services, in the amount of \$479,669.00 for The Keller Pointe Recreation and Aquatic Center, shall be paid from The Keller Pointe funds, and will require a future budget amendment.

AND IT IS SO RESOLVED.
