

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE BID FROM MCALLISTER'S LANDSCAPE, INC., OF FORT WORTH, TEXAS, FOR CONTRACTUAL SERVICES RELATING TO IRRIGATION SYSTEM REPAIR SERVICES, FOR THE PARKS AND RECREATION DEPARTMENT, FOR A ONE (1) YEAR PERIOD, WITH FOUR (4) ADDITIONAL ONE (1) YEAR RENEWAL PERIODS, NOT TO EXCEED FIVE (5) YEARS, IN AN AMOUNT NOT TO EXCEED \$100,000.00, PER YEAR; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL CONTRACT DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, a request for sealed bids for Irrigation System Repair Services for the Parks and Recreation Department was duly advertised in accordance with State law, and said bids were received, opened, and read aloud at 2:00 p.m., on Wednesday, January 6, 2021; and

WHEREAS, the FY 2020-21 Parks and Recreation General Fund Budget provides for Irrigation System Repair Services for the Parks and Recreation Department; and

WHEREAS, the three (3) sealed bids received have been reviewed by the Community Services Director, and it is determined that the bid received from McAllister's Landscape, Inc., of Fort Worth, Texas, is the lowest and most responsible bid.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby approves the bid from McAllister's Landscape, Inc., of Fort Worth, Texas, for contractual services relating to Irrigation System Repair Services, for the Parks and Recreation Department, for one-year term with the four (4) additional one (1) year renewal periods, not to exceed five (5) years, in an amount not to exceed \$100,000.00 per year; and further authorizes the City Manager to execute all contract documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of said Irrigation System Repair Services is allocated from the General Fund/Parks and Recreation Fund in the FY 2020-21 Adopted Budget.
