

GENERAL NOTES

1.) The purpose of this plat is to create three lots of record from unplatted tracts of land.

2.) This property is located in "Non-shaded Zone X" according to the F.E.M.A. Flood Insurance Rate Map dated September 25, 2009 as shown on Map Number 48439C0060K. The location of the flood zone shown hereon is approximate, as scaled from the FEMA Flood Insurance Rate Map.

3.) The grid coordinates shown on this plat are based on GPS observations utilizing the AllTerra RTK Network, North American Datum of 1983 (Adjustment Realization 2011). Texas North Central Zone 4202

4.) All interior property corners are marked with a 1/2-inch iron rod with a green plastic cap stamped "EAGLE SURVEYING" unless noted otherwise.

5.) The bearings shown on this plat are based on GPS observations utilizing the AllTerra RTK Network, North American Datum of 1983 (Adjustment Realization 2011).

6.) All setbacks shall be in accordance with zoning district, as described in the Keller Unified Development Code.

7.) An engineered grading plan is required to be submitted, reviewed and released for construction by the public works engineering department prior to issuance of a building permit.

FIRE SAFETY NOTES

1.) Any new homes built on Lots 1, 2, and 3, Block A, requires the installation of residential fire sprinklers for any home 6,000 square feet or greater.

2.) A separate tap and meter are required for fire supply lines.
