The property is on approximately 0.2591-acres, located at the corner of College St and Bear Creek Pkwy intersection, legally described as Block 3, Lot 12, of Park Addition (Keller), zoned Residential and addressed as 357 College St. Edward, Smola, Applicant/Owner. (ZBA-2410-0005)

Building Official gave a brief presentation of the property and variance request.

Chairperson Gilpin opened the Public Hearing.

Eric Warn at 357 Roy Ln stated that he was in favor of the variance request.

Motion was made by Chairperson Gilpin and second by TJ Stack to approve the requested variance.
