Scope of Work:

- Furnish, wire, and install (1) new 80kw 3-phase 120/208 Cummins Generator.
- Furnish, wire, and install (1) new Cummins transfer switch
- Furnish, wire, and install (1) new main 400amp fused disconnect switch
- Route new conduit and wire from the existing meter to the new main disconnect switch.
- Route new conduit and wire from the new disconnect switch to the new transfer switch.
- Route new conduit and wire from the new transfer switch to the existing main electrical panel located in the electrical room.
- Route new conduit and wire from the new transfer switch to the new 80kw generator.
- Make all final connections to the new main disconnect, new transfer switch, and new 80kw generator.
- New generator shall be installed on new generator approved concrete pad provided by Fort Worth Electric.
- Bid includes concrete cutting, pour back, and concrete repair.
- Bid includes natural gas installation from the existing meter to the new generator location by Fort Worth Electric Gas sub-contractor. Also includes natural gas generator terminations and testing. Does NOT include gas meter replacement or upgrade of gas utility if required.
- Bid includes Electrical Engineering Stamped drawings
- Bid include after business hours for generator service transfer

- Bid includes generator start up and testing by Cummins generators
- Bid includes disconnect and remove of the existing generator and transfer switch

Bid Includes: Labor / Materials / Generator / Transfer Switch / Disconnects / Breakers / Natural Gas Install / Saw Cut / Concrete Patch / Rental Equipment / Electrical Engineering Drawings

Bid Excludes: Utility Work for Electrical or Gas to Building / Gas Meter / Tax
