

ORDINANCE NO. 1927

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING A SPECIFIC USE PERMIT (SUP) TO ALLOW BRETT VANCE INSURANCE, A PROPOSED 'PROFESSIONAL OFFICE' USE, TO INCLUDE ALL ASSOCIATED BUSINESS WITH INSURANCE, TO OCCUPY A 1,598 SQUARE-FOOT BUILDING, LOCATED ON A 0.17-ACRE LOT ON THE WEST SIDE OF SOUTH MAIN STREET (US 377) APPROXIMATELY 52 FEET NORTHWEST OF SOUTH MAIN STREET (US 377) AND THE OLIVE STREET INTERSECTION, BEING A PORTION OF LOT 3 AND 4, BLOCK 5E, KELLER CITY ADDITION, AT 234 SOUTH MAIN STREET (US377) AND ZONED OTK (OLD TOWN KELLER). KELLER MAIN STREET DEPOT, LLC, OWNER; BRETT VANCE, APPLICANT. (SUP-19-0004).

WHEREAS, Keller Main Street Depot, LLC, owner, and Brett Vance, applicant has submitted an application to the City of Keller to request a Specific Use Permit (SUP-19-0004), which has been reviewed by the City Staff; and

WHEREAS, notice of a public hearing before the Planning and Zoning Commission was sent to real property owners within three hundred feet (300') of the property herein described at least ten (10) days before such hearing; and

WHEREAS, notice of a public hearing before the City Council was published in a newspaper of general circulation in Keller at least fifteen (15) days before such hearing; and

WHEREAS, public hearings to issue a Specific Use Permit on the property herein described were held before both the Planning and Zoning Commission and the City Council, and the Planning and Zoning Commission has heretofore made a recommendation to approve the Specific Use Permit; and

WHEREAS, the City Council is of the opinion that the Specific Use Permit herein effectuated furthers the purpose of zoning as set forth in the Unified Development Code and is in the best interest of the citizens of the City of Keller.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, in accordance with the Unified Development Code, the City Council of the City of Keller, Texas hereby authorizes approval of a Specific Use Permit (SUP) for a Specific Use Permit (SUP) to allow Brett Vance Insurance, a proposed 'professional office' use, to include all associated business with insurance, to occupy a 1,598 square-foot building, located on a 0.17-acre lot on the west side of South Main Street (US 377) approximately 52 feet northwest of South Main Street (US 377) and the Olive Street intersection, being a portion of Lot 3 and 4, Block 5E, Keller City Addition, at 234 South Main Street (US377) and zoned Old Town Keller (OTK) in the City of Keller, Tarrant County, Texas, with the proposal attached hereto as Exhibit "A", and incorporated herein, as if fully set forth with the following condition:

1. The Specific Use Permit request to allow Brett Vance Insurance to operate an insurance business within a 1,598 square-foot building for "professional Office" use in a vacant one-story building greater than 1,200 square-feet within (OTK) zoning shall be allowed.

This condition for this Specific Use Permit is specific for Brett Vance Insurance. Any new similar type business would require a new SUP application.

Section 3: THAT, any person, firm, or corporation violating any of the provisions of this Ordinance, as read together with the Unified Development Code and accompanying map thereto, shall be guilty of a misdemeanor and upon final conviction therefore shall be fined in a sum not to exceed Two Thousand Dollars (\$2,000.00). Each and every day such violation continues shall constitute a separate offense and shall be punishable as such hereunder.

Section 4: THAT, the City Secretary is hereby authorized and directed to cause publication of the descriptive caption and penalty clause hereof as an alternative method of publication provided by law.

AND IT IS SO ORDAINED.
