A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE PURCHASE OF ONE HPE ALLETRA STORAGE AREA NETWORK (SAN) DATA STORAGE ARRAY, FROM DATAVOX INC OF HOUSTON TEXAS, THROUGH THE STATE OF TEXAS DEPARTMENT OF INFORMATION RESOURCES (DIR) COOPERATIVE PURCHASING PROGRAM, FOR THE INFORMATION TECHNOLOGY DEPARTMENT, IN THE AMOUNT OF \$95,029.21; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL PURCHASE DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, the City Council of the City of Keller, Texas, has deemed it necessary and in the best interest of the citizens of the City of Keller to purchase and replace one HPE storage array, for the Information Technology Department; and

WHEREAS, the Fiscal Year 2023-24 Annual Budget provided for the purchase of said HPE product; and

WHEREAS, the purchase of said HPE product, through the State of Texas Department of Information Resources (DIR) Cooperative Purchasing Program, from Datavox Inc of Houston, Texas, has been determined to provide the best value and most responsible method of purchasing therefor.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas, hereby approves the purchase of HPE storage array, through the State of Texas Department of Information Resources (DIR) Cooperative Purchasing Program, for the Information Technology Department, in the total amount of \$95,029.21; and further authorizes the City Manager to execute all purchase documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of said purchase of HPE storage product, through the State of Texas Department of Information Resources (DIR) Cooperative Purchasing Program, for the Information Technology Department, in the total amount not to exceed \$95,029.21, shall be paid from the Information Technology Fund, budgeted therefor.
