

ORDINANCE NO. _____

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, AMENDING THE CITY OF KELLER CODE OF ORDINANCES BY DELETING CHAPTER 7, CITYWIDE SOLID WASTE COLLECTION AND RECYCLING SERVICES IN ITS ENTIRETY, AND ADDING A NEW CHAPTER 7, CITYWIDE SOLID WASTE COLLECTION AND RECYCLING SERVICES; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A PENALTY; AUTHORIZING PUBLICATION; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, Chapter 7 of the City of Keller Code of Ordinances provides for Citywide Solid Waste Collection and Recycling Services; and

WHEREAS, the City is preparing to enter into a new agreement for citywide solid waste collection and recycling services; and

WHEREAS, as a result of the new agreement, changes to the existing Ordinance are necessary; and

WHEREAS, the City Council desires to incorporate the citywide solid waste collection and recycling services agreement by reference and retain provisions necessary for sanitation, public health, and code compliance; and

WHEREAS, upon the deliberation of the Mayor and City Council of the City of Keller, Texas, it is deemed to be in the best interest of the health, safety and general welfare of the citizens of the City of Keller that the City of Keller Code of Ordinances be hereby amended by deleting Chapter 7, Citywide Solid Waste Collection and Recycling Services in its entirety and adding a new Chapter 7, Citywide Solid Waste Collection and Recycling Services, as shown in Exhibit "A" and attached hereto.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, Chapter 7, Citywide Solid Waste Collection and Recycling Services, of the City of Keller Code of Ordinances, is hereby amended by deleting Chapter 7, Citywide Solid Waste Collection and Recycling Services in its entirety and adding a new Chapter 7, Citywide Solid Waste Collection and Recycling Services, as shown in Exhibit "A" and attached hereto.

Section 3: THAT, any person, firm or corporation violating any of the provisions of this Ordinance shall be deemed guilty of a misdemeanor and shall, upon final

conviction thereof, be fined in an amount not to exceed Five Hundred Dollars (\$500.00). Each and every day any such violation continues shall constitute a separate offense and shall be punishable as such hereunder.

Section 4: THAT, if any section, paragraph, clause, phrase, or provision of this Ordinance shall for any reason be held to be invalid or unenforceable, the validity or unenforceability of such section, paragraph, clause, phrase, or provision shall not affect any of the remaining provisions of this Ordinance.

Section 5: THAT, the City Secretary is hereby authorized and directed to cause publication of the descriptive caption and penalty clause of this Ordinance as an alternative method of publication provided by law.

Section 6: THAT, this Ordinance shall become effective upon its adoption and publication provided by law.
