A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING A CONSTRUCTION PROPOSAL FROM ANDERSON ASPHALT AND CONCRETE OF DALLAS, TEXAS; FOR THE SHADY GROVE ROAD RECONSTRUCTION PROJECT FOR THE PUBLIC WORKS DEPARTMENT, THROUGH THE INTERLOCAL PURCHASING SYSTEM COOPERATIVE PURCHASING PROGRAM, IN THE AMOUNT OF \$768,005.80; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, the City Council of the City of Keller, Texas, has deemed it necessary and in the best interest of the citizens of the City of Keller to design and construct the Shady Grove Reconstruction Project (Keller-Smithfield to Rapp Road) for the Public Works Department; and

WHEREAS, these reconstruction services are available through the TIPS-USA purchasing cooperative; and

WHEREAS, Anderson Asphalt and Concrete of Dallas, Texas continues to hold a valid cooperative purchasing agreement through TIPS-USA; and

WHEREAS, city staff recommends approval of the construction proposal from Anderson Asphalt and Concrete of Dallas, Texas in the amount of \$768,005.80.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby approves the construction proposal for the Shady Grove Reconstruction Project from Anderson Asphalt and Concrete of Dallas, Texas; through The Interlocal Purchasing System cooperative purchasing program, in the amount of \$768,005.80; and authorizing the City Manager to execute all purchase documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of said project shall be paid from the Street System Capital Improvements Project Fund, and the Keller Development Corporation Capital Improvements Project Fund in the amount of \$768,005.80 budgeted therefor.

Section 4: THAT, this resolution shall be effective upon its adoption.
