

RESOLUTION NO. 4372

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE ANNUAL PURCHASE OF SUPPLEMENTAL CONCRETE CONTRACTOR SERVICES, FROM APEX CONCRETE CONSTRUCTION, INC. OF KELLER, TEXAS, THROUGH THE INTERLOCAL AGREEMENT WITH THE CITY OF NORTH RICHLAND HILLS, DATED JULY 19, 2005, FOR THE PUBLIC WORKS DEPARTMENT, IN AN AMOUNT NOT TO EXCEED \$240,000, AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL PURCHASE DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, the City Council of the City of Keller, Texas, has deemed it necessary and in the best interest of the citizens of the City of Keller to purchase Supplemental Concrete Contractor Services for the Public Works Department; and

WHEREAS, the Fiscal Year 2020-21 Annual Budget provides for the purchase of said Supplemental Concrete Contractor Services; and

WHEREAS, the City of Keller has entered into an Interlocal Agreement with the City of North Richland Hills, with the adoption of Resolution No. 2316, dated July 19, 2005, allowing the two cities to utilize contracts entered into by each other relative to governmental functions and services, pursuant to the authority granted by Article 791 et seq. of the Interlocal Cooperation Act, Texas Government Code; and

WHEREAS, the City of North Richland Hills has competitively bid for Supplemental Concrete Contractor Services and Apex Concrete Construction, Inc. provides the best value; and

WHEREAS, the City of Keller is authorized to use the unit prices submitted by Apex Concrete Construction Inc. for Supplemental Concrete Contractor Services; and

WHEREAS, the proposed agreement shall last one (1) year with the option to extend said agreement for an additional four (4) one (1) year periods; and

WHEREAS, funding for additional one (1) year periods is contingent upon budget approval by the City Council for concrete replacement, repair, and installation services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, City Council of the City of Keller, Texas, hereby approves the purchase of Supplemental Concrete Contractor Services from Apex Concrete Construction of Keller, Texas, through the Interlocal Agreement with the City of North Richland Hills, dated July 19, 2005, for the Public Works Department, in an amount not to exceed \$240,000, according to the terms and conditions set forth in Exhibit "A" attached hereto, and authorizing the City Manager to execute all purchase documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of the Supplemental Concrete Contractor Services purchase shall be paid from the Public Works Street Maintenance Division and CIP, budgeted therefor.

AND IT IS SO RESOLVED.
