

Discuss Medical and Spa-related uses, and allowed uses in the Town Center Zoning District

Tonight's discussion is prompted in part by:

- Increased interest in medical spas without a clear pathway for approval in the Unified Development Code (UDC)
- Lack of spa definition in the UDC
- Need to revisit allowed uses in Town Center Zoning District

Recent Medical Spa Applicant Proposed Services:

Example A (Requesting Spa in TC District):

- Botox
- Fillers
- PDO lifting threads
- Platelet-rich plasma facial with microneedling
- Radiofrequency microneedling
- Body contouring
- Laser hair removal
- Mesotherapy
- Kybella therapy
- IV Nutrition therapy
- Weight loss shots
- Hormone replacement therapy
- Energy shots
- Anti-aging shots
- Facials
- Skin care products and supplements

Example B (Requesting Medical in Retail District):

- Facials
- Injectables
- Chemical peels
- Waxing
- Brows and lashes
- Nails
- Microneedling
- Lasering
- Tans

Example C (Requesting Medical in Commercial District):

- Permanent cosmetics
- Facials
- Microneedling
- Weight loss consulting

Current UDC Definitions


- Medical Facilities:
 - Convalescent, Rest or Nursing Home
 - Dental, Medical or Chiropractic Clinic
 - Hospital
 - Massage Establishment

- Minor Emergency Care Clinic
- Optometrist
- Sanitarium
- Surgical Out-patient Facility
- Barber Shop or Beauty Salon An establishment that performs personal grooming services such as haircuts, nail, facial treatments, etc.

There is no definition for Spa, only descriptive language in individual district use charts: "Spa to include Cosmetologists (Hair, Nails, Face) & Massage Therapists Licensed in TX."

Medical Spas

- Businesses that offer medical procedures in addition to cosmetology services.
 - Platelet-rich plasma injections (O-shot), coolsculpting, hormone replacement therapy, microdermabrasion and dermaplaning, dermal fillers (Botox, Dysport), laser hair removal, body contouring, intense pulse light therapy (photofacials), and microneedling and microblading
- Regulated by Texas Department of Licensing and Regulation (TDLR)
 Cosmetology Statute and the Texas Medical Governing Board.
- Required to be under the supervision of a medical license.

Proposed Modified Barber Shop/Beauty Salon Definition

Barber Shop or Beauty Salon - An establishment that performs personal grooming services such as haircuts, trimming, coloring and styling.

Proposed Spa Definition

Any commercial establishment that offers to the public massage therapy, barbering and/or cosmetology services (Hair, Nail, Face) performed by persons licensed in TX and may include the retail sale of goods incidental to the services of the spa.

Proposed Medical Spa Definition

A spa combined with a medical clinic that offers non-invasive medical cosmetic procedures. All medical procedures must be conducted under the supervision of a licensed physician.
