C. PERSONS TO BE HEARD

This is a time for the public to address the Commission on any subject. However, the Texas Open Meetings Act prohibits the Commission from discussing issues which the public has not been given seventy-two (72) hours' notice. Issues raised may be referred to City Staff for research and possible future action. Each speaker will be allowed three (3) minutes to speak.

D. NEW BUSINESS

 Consider a request for a mural at Swanky Chic, located on Lot 1, Block 7 of Keller City Addition, being .23-acres at 241 South Main Street, located on the west side of U.S. Hwy 377 and zoned Old Town Keller (OTK). Lori Cimonetti, Owner. Swanky Chic Boutique, Applicant. Victoria Zietsman, Artist. (MUR-23-0001)

CDD Hensley gave a presentation on Item D-1, a Mural request for Swanky Chic at 241 S. Main St.

- A motion was made by Commissioner Vernon Stansell, seconded by Commissioner Gregory Will, to recommend approval for Item D-3 as presented. The motion carried unanimously.
- 2. PUBLIC HEARING: Consider a request for a Specific Use Permit (SUP) for an approximately 3,196 square-foot accessory structure with an average height of 25 feet 4

inches, on approximately 0.77 acres, on the west side of Bellechase Drive, approximately 635 feet northwest from the intersection of Bellechase Drive and Melody Lane, legally described as Lot 5, Block 1 of Belaire Hills Estates, zoned Single-Family 36,000 square-foot lot size or greater (SF-36) and addressed 1520 Bellechase Drive. Jeffrey Peck, Applicant/Owner. (SUP-23-0037)

Prior to the meeting, the Applicant requested to withdraw Item D-2 from consideration, so the Commission did not hold a public hearing or take action on the item.

This New Business was withdraw.

3. PUBLIC HEARING: Consider a request for a Specific Use Permit (SUP) for an event venue in approximately 610 square-feet of an existing lease space, on .14 acres, on the south side of Olive Street, approximately 225 feet southeast from the intersection of South Main Street and Olive Street, legally described as Lot 3R, Block 7 of the Keller, City Addition, zoned Old Town Keller (OTK) and addressed 138 Olive Street. Marissa Bryson, Applicant. Main Street Depot, LLC, Owner. (SUP-23-0038)

Planner Washington gave a presentation for Item D-3, an SUP request for an event venue at 138 Olive Street.

Chairman Alvarado opened the public hearing.

No public comments received.
