1. [PUBLIC HEARING: CONSIDER AN APPEAL TO THE CITY OF KELLER CODE OF ORDINANCES, ARTICLE IX. - SEX OFFENDER RESIDENCY RESTRICTIONS, REQUESTED BY MR. VERNON LEE, TO ESTABLISH A PERMANENT RESIDENCE WITHIN ONE THOUSAND \(1,000\) FEET OF A CHILD SAFETY ZONE, AT 565 BANCROFT ROAD IN THE CITY OF KELLER.](#)

Mr. Vernon Lee, applicant, addressed the City Council regarding his request to establish his permanent residency at 565 Bancroft Road, which is within one thousand feet of a Child Safety Zone.

Police Chief Bradley Fortune briefed the City Council regarding the timeline of events relating to Mr. Lee's violations.

Mayor Armin Mizani opened the public hearing.
