As an 18-year resident of Keller, I have voted for most of you. I appreciate the challenging work that you are doing during these difficult times. I would especially like to thank Mayor Mizani for the transparency in posting the body- and dash-cam videos.

This is not a "one bad apple" situation because Blake Shimanek was hired, trained, and promoted by this city – using our tax money. Additionally, after the police misconduct in August, he was retained, not fired.

Anyone watching the bodycam video can see that something went horribly wrong, and it did not begin on that day, nor will it end when Mr. Shimanek is finally fired.

If you intend to restore public faith in our police and the reputation of our city, you must act to investigate the system that allowed this abuse to happen and that chose to retain Mr. Shimanek.

#### Questions:

- 1) Why were you not informed about this incident in August?
- 2) Since you all believe in transparency, will you provide an (opt-in) alert for use-of-force investigations, with public access to video, and a chance for public comment? We should not have to wait for a year-end report.
- 3) When a system fails, the origins of the failure must be examined and remedied; otherwise, we can expect additional failures. What is the city doing to investigate the errors of hiring, promoting, and retaining Mr. Shimanak?
- 4) This incident has harmed the City of Keller's image. Other than changes in policing, how can

you make our city and its businesses more welcoming to all?

#### **5.** Comment:

I am writing in today to express my concerns over the Puente arrest and assault. I am a previous Keller resident and I still frequently go into Keller, multiple times every week, and so I still feel that this effects me and any future of my return to Keller. The video of the entire situation with Marco and Dillon Puente is absolutely infuriating and it is clear that Officer Shimanek should not be a police officer for any city. I am concerned that the Chief's Advisory Council only suggested to demote him and not fire him. I do believe that Officer Shimanek should be fired and should find a better fitting career.

However, this is not about just one officer and one incident. It is clear that the entire situation happened due to systemic failures. Why did the city council not hear about this until the lawsuit came about? Why did the public not hear about this until the lawsuit? Why was the Chief of Police protecting the officer and not the public?

There is also some frustration in that I am a part of a local community group, the Anti-Racism Coalition for Black Lives, that met with Chief Fortune in July, prior to this incident. This scenario is something we were trying to make sure wouldn't happen in Keller. We were reassured by Chief Fortune of all of the accolades and training that Keller PD receives. We also asked him to fill us in on several questions we had. He assured us all of this would be answered in a FAQ on the city website so that all residents would be able to know. However this has not been done. How are residents and those that choose to do business in Keller supposed to feel safe if there is no transparency?

With all of the information, I want to restate again to the city council, that this needs to be not just resolved by firing Officer Shimanek, but that there is a thorough and intense examination of the systemic nature of this racism that was displayed for the entire country to see. Please do not ignore this and bury it. Do not stop with any recommendation for firing of the officer. More must be done. Thank you.

### 5. Comment:

I watched the video released from the Keller PD of the incident in August 2020, recording the pull over, arrest of Dillon Puente and subsequent pepper spraying of Marco Puente. I ask you, Keller City Council... where are the good apples? Why would I, as a citizen of Keller, ever back the blue in this instance of horrific abuse of power by Officer Shimanek? I see that Keller PD has at least two bad apples in its ranks, plain and simple. Officer Shimanek and Officer Tomer need to go. The meager slap on the wrist to demote Officer Shimanek illustrates just how deep the racism is within the Keller PD and shines a light on the department's inability to recognize right from wrong.

Yet, Keller PD apologized for what they know was a tragic event caused solely by Officer Shimanek and his escalating temper, but still they keep him on the payroll... a payroll that we all pay for with our tax dollars. I'd prefer my tax dollars not go towards the salary and pension of a cop who can't control his temper and harasses citizens. The fact that Officer Shimanek still has a job after such a disgusting display of arrogance and disrespect is appalling.

We, as citizens, will all pay the price in legal fees when the Keller PD is taken to court. We will pay for Officer Shimanek's crime. So, no. Not in my backyard. Officer Shimanek doesn't deserve a demotion. He deserves to lose his job. What will it be next time Officer Shimanek decides to pull over and arrest someone for a "wide right turn"? Fire both officers now. Otherwise, you send a message to other officers that behavior like this is a simple slap on the wrist. Let Officer Shimanek and Officer Tomer pay for their actions. I ask the city council and Keller PD to stop sheltering overly aggressive officers.

To the city council: This is what racism looks like. If you want to lead our city out of this mess, start by doing the right thing. If the city council has one ounce of integrity, it will right this wrong and FIRE Officer Shimanek for spearheading this awful incident and Officer Tomer for not being the good apple and resisting his superior's orders to pepper spray Mr. Puente when there was no need. A man with a camera making a video of his son's bogus arrest, does not warrant this escalation in events. Also, no one should ever be arrested for I quote, "acting suspicious" and "having the window not fully down." The video clearly recorded these phrases spoken by Officer Shimanek and showed his turn of anger when he realized he would be caught on videotape terrorizing an innocent civilian from his position of authority.

I am thankful that the video exists so that citizens like myself can see exactly where their tax dollars are being spent... on racist cops with anger issues. Send these officers packing. If not, the city council and every one at the Keller PD is rotten to the core morally. Also, you can bet I'm mad. We all should be. This is what racism looks like. Any other response other than firing these officers shows incredible weakness from the Keller PD and the city council. Do the right thing.

years. The events from August where two members of the Keller PD showed such glaring disgust for the citizens they are charged with protecting, sadly, is not surprising. Police officers are supposed to represent the highest standards of conduct - they are supposed to be the symbols of highest good, fostering the highest levels of trust among the people, citizens, and communities in which they serve. It is not unreasonable for a citizen to expect these qualities in each and every interaction that they have with a police officer, especially in Keller. But the lack of transparency regarding this event, the horribly bad judgment on the part of the officer who clearly abused the power of his position, and the lack of suitable punishment of this officer in light of the very public facts is disturbing to say the least. This officer has had multiple infractions and yet was promoted to Sergeant. Further, from the report the officer filed, he clearly lied about the encounter, grossly misstating multiple things that he invariably assumed would not be challenged given his past infractions. I'm not surprised that this is case as I was part of the Keller Citizen Police Academy prior to COVID-19. One of the classes was talking about how officers engage criminals, yet the focus of the class was on showing a few videos where the officers bemoaned how the media portrayed the actions of the officers. These officers were clearly ok with abusing the rights of innocent citizens because it was the media's fault for skewing the facts. I was shocked, to say the least, as one of only two people of color in that class to see these officers being so blatantly flippant about this kind of abuse of power. In fact, one of the videos shown shows the person pulled over having done nothing wrong yet is yanked out of the vehicle and then beaten by officers - this was celebrated because the person beaten shouldn't have "mouthed off" to the officers. This is not policing - this is fascism. So am I surprised when the father of the individual who was exercising his constitutionally protected right to record video in a public space was deemed "offensive" by this officer? No, sadly I'm not as this is appears to be the pervasive nature of the police department. With that said, I strongly support law enforcement but I also strongly support the identification and removal of bad police officers who ruin and tarnish the reputation that police officers are supposed to have. But ask yourself this, is it truly an "offense" when someone makes a wide right turn? Is it truly an "offense" when someone rolls up their window in the middle of a pandemic? Is it truly an "offense" when people exercise their constitutionally protected rights? This entire encounter could've been avoided if the Keller PD didn't deem these things to be "offenses" worthy of getting involved - this is no different than the "broken windows" police tactics employed in NY that led to the death of Eric Garner.

It is not enough that this officer was demoted. His gross negligence and lack of respect for people deems him unfit to wear the badge or the uniform. Someone so unstable and egotistical is a danger and threat to every citizen who calls Keller home. This man and his partner do not deserve the privilege of being police officers and nothing less than firing these men and making sure they are unable to become police officers anywhere else will not be considered justice. It is high time that people of color feel as though encounters with the police won't end up as life and death situations. Firing these men and taking a long look at how the Keller PD engages in "offenses" are steps in the right direction that need to be taken.

The fact that the lead officer then had a second officer arrest the father and the two of them handcuffed him and while he is hand cuffed and on the ground they kneel on his back and pepper spray him is absolutely uncalled for. Did neither of these officers learn anything from the George Floyd incident? Anyone who is hand cuffed and on the ground can be controlled with little to no force with no need to kneel on them and/or pepper spray them.

Regarding the second officer on the scene, I don't know why the Keller Chief of Police has not instructed all his officers to use their own brain rather then carry out the orders of even a senior officer to do something uncalled for and stupid.

Thank you for listening.
I have been a resident of Keller since 2001. I have always supported the police. However, there are real-life implications to the people Shimanek is affecting.
Regarding the August 15, 2020 incident, Shimanek's conduct was way out of line. And he involved other officers in his abusive behavior. I found it hard to watch as Shimanek handcuffed, ticketed, and took the young man to jail for making a wide right turn or when Shimanek and Officer Tomar wrestled the father to the ground, pepper-sprayed, and arrested him. The Puente's could not have been more respectful and compliant.
This is not the first time Shimanek has abused his power and used narcotics as a pretense. I have direct experience with this. He alleged that my son possessed narcotics and he didn't. In fact, another officer was heard saying, "I searched the car and there was nothing there, and I didn't smell anything." But that did not stop Shimanek from issuing a citation and publicly humiliating someone he identified as vulnerable. I requested a copy of the police report and video footage, on multiple occasions, but was ultimately offered only an abbreviated report I had already obtained from Keller High. The implied message was that I was unable to view the full report of my son's citation. Even from this small instance of being denied information, it shows that the problem extends beyond Shimanek as others are willing to protect him.
This is a pattern, which needs to be arrested - immediately.
In my opinion, Shimanek needs to be removed from the police force and taken completely off of the City of Keller payroll. Officer Tomar's behavior was violent. I was surprised he acted without question. In my opinion, though, he needs to be severely reprimanded, but not fired. He was acting on orders from a superior officer, not knowing what preceded his arrival. I also believe Shimanek's superiors should be investigated to determine why it is that he has been allowed to continue abusing his power. *
The Puente's have done a public service by bringing this to light.
The decision you make is not just going to affect Shimanek, but it's also going to define what we want the City of Keller to be. I for one want it to be a place where peaceful citizens feel safe.
*Note: Aside from the August 15 incident, my son's experience, or 2016 incident where Shimanek entered a house without a warrant or permission and threatened a woman with reporting her to CPS, perhaps the comment below helps explain why this has continued. *Ryan Dobbs·1 week ago As a former Keller police officer, this isn't the first or second instance of Shimanek violating many policies. But since he was the favorite among those in administration, nothing was ever done about it. This is what happens when bad officers are not held accountable for their actions. The city manager, former chief, and 2 current captains are responsible for letting this happen.

Keller should further pay for counseling for this incident because I would have anxiety for a long time and be fearful of our police. Police are protectors. Yes they have a tough job because they do not know what they are approaching. But there job is not to induce stress and anxiety that was clearly on display and verbalized by the younger Mr. Puente. With Shimanek proposed experience and why he got a promotion is daunting. Based on his longevity as an officer he should have been able to determine that in minute 15 of this incident and not 54 minutes later.

I am looking to the top brass at City of Keller PD and City to do the RIGHT thing, by NOT overlooking this and providing full transparency.
