

#### Requests for variances to landscape requirements:


We are requesting the following variance to the landscape requirements for the Keller ISD New Career & Technology Center:

#### Landscape Variance

Section 8.08 (F.3.c) Landscape island not installed due to this area being used as a drop off lane by South Keller Intermediate School.

The drive with the landscape island in discussion was supposed to be built during summer 2015. However, South Keller Intermediate school was still in use during the 2015-2016 school year, and the only location for school bus drop-off was in the location where this island was designed. The island was omitted for this reason, and was not subsequently built due to the phased nature of the project.

The district wants to avoid further disruption to the campus and the traffic flow on the site and is requesting a variance to eliminate the parking island. The tree indicated in this island has been planted on site to meet the caliper calculations indicated in the drawings.



## Item H-4 Analysis

Section 2.07(A.2) of the UDC, lists criteria for approval of a variance.

- Special conditions affecting the land deprive the applicant of reasonable use of his land.
  - Staff finds no special conditions affecting the land.
- The variance will not be detrimental to the public health, safety or welfare, or injurious to other properties in the area.
- The variance will not prevent orderly subdivision of other lands in the area.
- The variance will not violate other valid ordinances.
- The purpose of the regulations will be served to a greater extent by the alternative proposal.
  - The landscape island with tree would better serve the purpose of the regulations
- Compliance could be achieved during a school break to avoid disruption.

The Planning and Zoning Commission voted 5-1 to recommend approval of this variance at their November 21, 2017 meeting.
