D. ELECTIONS

1. <u>Consider a resolution canvassing the Runoff Election duly held in the City of Keller, Texas,</u> on the 8th day of December 2020, for Mayor.

City Secretary Kelly Ballard announced that Official Results from the City of Keller Runoff Election for Mayor reflected the following results:

Tag Green: 2,675 votes / 41.12% Armin Mizani: 3,831 votes / 58.88%

Mr. Armin Mizani is declared to have been elected to the office of Mayor, to serve a three (3) year term expiring May, 2023.

A motion was made by Council Member Mitch Holmes, seconded by Council Member Beckie Paquin, to approve Resolution No. 4321 canvassing the Runoff Election duly held in the City of Keller, Texas, on the 8th day of December 2020, for Mayor. The motion carried unanimously.
