A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING AN AGREEMENT WITH NEEL-SCHAFFER, INC., OF ARLINGTON, TEXAS, TO PROVIDE ENGINEERING SERVICES RELATING TO DESIGN OF THE RECONSTRUCTION OF THE PARKING LOTS AND STREETS AT THE KELLER SPORTS PARK, FOR THE PARKS AND RECREATION DEPARTMENT, IN THE AMOUNT OF \$399,400.00; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL CONTRACT DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, the City Council of the City of Keller, Texas, has deemed it necessary and in the best interest of the citizens of the City of Keller to design parking lot and street improvements to the parking lots and streets at the Keller Sports Park; and

WHEREAS, the City Staff has reviewed the qualifications of Neel-Schaffer, Inc. of Arlington, Texas, and concluded this firm is well qualified to provide design services for said project; and

WHEREAS, the firm of Neel-Schaffer, Inc. of Arlington, Texas is hereby recommended to provide said engineering services in accordance with the terms and conditions set forth in the Keller Sports Park Lots & Roadway Rehab Proposal.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby approves an Agreement with Neel-Schaffer, Inc., of Arlington, Texas to provide engineering services, relating to the reconstruction of the parking lots and streets in the Keller Sports Park, in the amount of \$399,400.00, in accordance with the terms and conditions set forth in said Professional Engineering Services Agreement; and further authorizes the City Manager to execute all contract documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of said project shall be paid in the amount of \$399,400.00 by the Parks System Capital Improvement Program Fund. Funds for the project were provided by the Keller Development Corporation Fund and the General Fund.
