ORDINANCE NO. 1829

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING A SPECIFIC USE PERMIT (SUP) FOR MASSAGE EXPRESS, A PROPOSED SPA TO INCLUDE COSMETOLOGISTS (HAIR, NAILS, FACE) & MASSAGE THERAPIST, IN AN EXISTING LEASE SPACE OF 1,196 SQUARE FEET, WITHIN A 15,032 SQUARE-FOOT BUILDING ON 1.87-ACRES, LOCATED ON THE NORTH SIDE OF NORTH TARRANT PARKWAY, APPROXIMATELY 200 FEET EAST OF RUFE SNOW DRIVE, AT 841 NORTH TARRANT PARKWAY, BEING LOT 2, BLOCK A, HIGHLAND OAKS CROSSING ADDITION, AND ZONED PD-R (PLANNED DEVELOPMENT-RETAIL), IN THE CITY OF KELLER, PROVIDING A TARRANT COUNTY, TEXAS; PENALTY; AUTHORIZING PUBLICATION.

WHEREAS, Keller Retail Partners, LLC, owner/applicant; has submitted an application to the City of Keller to request a Specific Use Permit (SUP-16-0028), which has been reviewed by the City Staff; and

WHEREAS, notice of a public hearing before the Planning and Zoning Commission was sent to real property owners within three hundred feet (300') of the property herein described at least ten (10) days before such hearing; and

WHEREAS, notice of a public hearing before the City Council was published in a newspaper of general circulation in Keller at least fifteen (15) days before such hearing; and

WHEREAS, public hearings to issue a Specific Use Permit on the property herein described were held before both the Planning and Zoning Commission and the City Council, and the Planning and Zoning Commission has heretofore made a recommendation to approve the Specific Use Permit; and

WHEREAS, the City Council is of the opinion that the Specific Use Permit herein effectuated furthers the purpose of zoning as set forth in the Unified Development Code and is in the best interest of the citizens of the City of Keller.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: accordance with the Unified THAT, in Development Code, the City Council of the City of Keller, Texas hereby authorizes approval of a Specific Use Permit (SUP) for Massage Express, a proposed Spa to Include Cosmetologists (Hair, Nails, Face) & Massage Therapist, in an existing lease space of 1,196 square feet, within a 15,032 squarefoot building on 1.87-acres, located on the side of North Tarrant Parkway, north approximately 200 feet east of Rufe Snow Drive, at 841 North Tarrant Parkway, being Lot 2, Block A, Highland Oaks Crossing zoned Addition and, PD-R (Planned Development-Retail), in the City of Keller, Tarrant County, Texas, with the proposal attached hereto as Exhibit "A", incorporated herein, as if fully set forth with the following conditions:
 - 1. A Specific Use Permit for Massage Express to operate a 'Spa to Include Cosmetologists (Hair, Nails, Face) & Massage Therapist' use in a 1,196 square feet lease space, at 841 North Tarrant Parkway, within the PD-R (Planned Development Retail) zoning district shall be allowed.
- Section 3: THAT, any person, firm, or corporation violating any of the provisions of this Ordinance, as read together with the Unified Development Code and accompanying map thereto, shall be guilty of a misdemeanor and upon final conviction therefore shall be fined in a sum not to exceed Two Thousand Dollars (\$2,000.00). Each and every day such violation continues shall constitute a separate offense and shall be punishable as such hereunder.
