ORDINANCE NO. 1855

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING A SPECIFIC USE PERMIT (SUP) TO ALLOW THE USE OF A SPA TO INCLUDE COSMETOLOGISTS (HAIR, FACE) & MASSAGE THERAPISTS LICENSED IN TX, FOR EVERGREEN MASSAGE, A PROPOSED MASSAGE THERAPY BUSINESS EXISTING MULTI-TENANT BUILDING OF APPROXIMATELY 16,380 SQUARE FEET, ON AN APPROXIMATELY 2.01-ACRES, LOCATED ON THE WEST SIDE OF SOUTH MAIN STREET (US HWY APPROXIMATELY 500 FEET NORTH OF WALL-PRICE KELLER ROAD, AT 900 SOUTH MAIN STREET, BEING LOT 2, BLOCK A, BEAR CREEK PLAZA ADDITION AND ZONED C (COMMERCIAL), IN THE TARRANT COUNTY, CITY OF KELLER, TEXAS; PROVIDING A PENALTY; AND AUTHORIZING PUBLICATION.

WHEREAS, BC/Tibex L.P., owner; Quine & Associates, Agent, and Michael Postlethwait, applicant; have submitted an application to the City of Keller to request a Specific Use Permit (SUP-17-0012), which has been reviewed by the City Staff; and

WHEREAS, notice of a public hearing before the Planning and Zoning Commission was sent to real property owners within three hundred feet (300') of the property herein described at least ten (10) days before such hearing; and

WHEREAS, notice of a public hearing before the City Council was published in a newspaper of general circulation in Keller at least fifteen (15) days before such hearing; and

WHEREAS, public hearings to issue a Specific Use Permit on the property herein described were held before both the Planning and Zoning Commission and the City Council, and the Planning and Zoning Commission has heretofore made a recommendation to approve the Specific Use Permit with a condition; and

WHEREAS, the City Council is of the opinion that the Specific Use Permit herein effectuated furthers the purpose of zoning as set forth in the Unified Development Code and is in

the best interest of the citizens of the City of Keller.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: in accordance with the Unified THAT, Development Code, the City Council of the City of Keller, Texas hereby authorizes approval of a Specific Use Permit (SUP) to use of allow the a Spa to include Cosmetologists (Hair, Nails, Face) & Massage Therapists Licensed in TX, for Evergreen Massage, a proposed massage therapy business an existing multi-tenant building approximately 16,380 square feet, approximately 2.01-acres, located on the west side of South Main Street (US HWY 377), approximately 500 feet north of Wall-Price Keller Road, at 900 South Main Street, being Lot 2, Block A, Bear Creek Plaza Addition and zoned C (Commercial), in the City of Tarrant County, Texas, with the proposal attached hereto as Exhibit "A", and incorporated herein, as if fully set forth with the condition below:
 - The Specific Use Permit for Evergreen 1. massage to operate a 'Spa to Include Cosmetologists (Hair, Nails Face) Massage Therapist' use in an existing multi-tenant building of approximately 16,380 square feet, on an approximately 2.01-acres, located on the west side of (US South Main Street HWY approximately 500 feet north of Wall-Price Keller Road, at 900 South Main Street, within the C (Commercial) zoning district shall be allowed.
- Section 3: THAT, any person, firm, or corporation violating any of the provisions of this Ordinance, as read together with the Unified Development Code and accompanying map

thereto, shall be guilty of a misdemeanor and upon final conviction therefore shall be fined in a sum not to exceed Two Thousand Dollars (\$2,000.00). Each and every day such violation continues shall constitute a separate offense and shall be punishable as such hereunder.

Section 4: THAT, the City Secretary is hereby authorized and directed to cause publication of the descriptive caption and penalty clause hereof as an alternative method of publication provided by law.
