The sign has been in place since 2003.

It was erected before I bought the business in 2004

The sign serves a HUGE purpose in attracting customers traveling east on Keller Hicks rd. Customers have stated to us that without that sign they would not have known we were here because traffic generally turns south at the 377 intersection of Keller Hicks rd. The sign is in NO WAY a hindrance or safety issue and is secured to the steel frame of the building and has withstood 80+ mph winds.

The sign was taken down and re-lettered in 2016.

Any smaller of a sign and customers would not be able to see it due to the distance between the back of the building to the railroad tracks and Katy/Keller Hicks rd. Please take all this into consideration before making your decision.
