

RESOLUTION NO. 3946

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, AUTHORIZING THE USE OF THE COMPETITIVE SEALED BID METHOD FOR THE WALL PRICE KELLER ROAD RECONSTRUCTION PROJECT AS THE BEST VALUE PROJECT DELIVERY METHOD FOR THE CITY OF KELLER, OTHER THAN COMPETITIVE BIDDING AND DELEGATING AUTHORITY TO THE CITY MANAGER OR HIS DESIGNEE, AND ESTABLISHING THE LIMITS OF THAT AUTHORITY AS ALLOWED BY TEXAS GOVERNMENT CODE CHAPTER 2269, SUBCHAPTER F, TO IMPLEMENT THE COMPETITIVE SEALED BID METHOD FOR THE CITY OF KELLER, TEXAS.

WHEREAS, it has been determined by the City Council of the City of Keller, Texas, that it is in the best interest of the health, safety and general welfare of the citizens of the City of Keller, Texas, to design and construct the Wall Price Keller Road Reconstruction project; and

WHEREAS, the complexity of this project warrants using other contracting and delivery methods than competitive bidding for construction as allowed by State of Texas Government Code Chapter 2269; and

WHEREAS, it has been determined by the City Council of the City of Keller, Texas to delegate authority to the City Manager, or his designee, to implement the Competitive Sealed Bid Method for the Wall Price Keller Road Reconstruction project as allowed by State of Texas Government Code 2269, Subchapter F and take any action authorized or required without further action of the City Council, provided all supporting statutory findings have been made by the City Manager or his designee except that execution of the final construction delivery contracts will require the subsequent approval of the City Council; and

WHEREAS, it has been determined by the City Council of the City of Keller, Texas that the Competitive Sealed Bid Method provides the

best value for the Wall Price Keller Road Reconstruction project as described in the State of Texas Government Code.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby approves Competitive Sealed Bid as the best value for the Wall Price Keller Road Reconstruction project.

Section 3: THAT, the City Council hereby delegates authority to the City Manager, or his designee to implement the Competitive Sealed Bid Method for the Wall Price Keller Road Reconstruction project as allowed under Texas Government Code Chapter 2269, Subchapter F and take any action authorized or required without further action of the City Council, providing all supporting statutory findings have been made by the City Manager or his designee except that execution of the final construction contract will require the subsequent approval of the City Council.

Section 4: THAT, this resolution shall be effective upon its adoption.
