AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING A SPECIFIC USE PERMIT (SUP) TO ALLOW YING WANG SPA & BODY WORK, A PROPOSED "SPA TO INCLUDE COSMETOLOGISTS (HAIR, NAILS, FACE) & MASSAGE THERAPISTS LICENSED IN TX", LOCATED IN THE EXISTING SHOPS AT CINDY, A 9,995 SQUARE-FOOT MULTITENANT RETAIL BUILDING, ON A 0.84-ACRE LOT ON THE SOUTHWEST CORNER OF THE INTERSECTION OF KELLER PARKWAY (FM 1709) AND CINDY STREET, AT 460 KELLER PARKWAY (FM 1709), BEING LOT 1R, BLOCK A, THE SHOPS AT CINDY ADDITION, AND ZONED R (RETAIL), IN THE CITY OF KELLER, TARRANT COUNTY, TEXAS; PROVIDING A PENALTY; AND AUTHORIZING PUBLICATION.

WHEREAS, Ying Shu Yu, applicant; Bass Commercial Investments, LLC, owner; have submitted an application to the City of Keller to request a Specific Use Permit (SUP-17-0026), which has been reviewed by the City Staff; and

WHEREAS, notice of a public hearing before the Planning and Zoning Commission was sent to real property owners within three hundred feet (300') of the property herein described at least ten (10) days before such hearing; and

WHEREAS, notice of a public hearing before the City Council was published in a newspaper of general circulation in Keller at least fifteen (15) days before such hearing; and

WHEREAS, public hearings to issue a Specific Use Permit on the property herein described were held before both the Planning and Zoning Commission and the City Council, and the Planning and Zoning Commission has heretofore made a recommendation to approve the Specific Use Permit; and

WHEREAS, the City Council is of the opinion that the Specific Use Permit herein effectuated furthers the purpose of zoning as set forth in the Unified Development Code and is in the best interest of the citizens of the City of Keller.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: THAT, in accordance with the Development Code, the City Council of the City of Keller, Texas hereby authorizes approval of a Specific Use Permit (SUP) to allow Ying Wang Spa & Body Work, a proposed "Spa to include Cosmetologists (Hair, Nails, Face) & Massage Therapists Licensed in TX", located in the existing Shops at Cindy, a 9,995 square-foot multitenant retail building, on a 0.84-acre southwest on the corner intersection of Keller Parkway (FM 1709) and Cindy Street, at 460 Keller Parkway (FM 1709), being Lot 1R, Block A, The Shops at Cindy Addition, and zoned R (Retail), in the City of Keller, Tarrant County, Texas, with the proposal attached hereto as Exhibit "A", and incorporated herein, as if fully set forth with the following condition:
  - 1. A Specific Use Permit for Ying Wang Spa & Body Work, a proposed "Spa to include Cosmetologists (Hair, Nails, Face) Massage Therapists Licensed in TX", located in an existing 9,995 square-foot multi-tenant retail building at Keller Parkway (FM1709) shall be allowed. This specific use permit is specific to Ying Wang Spa & Body Work. Any other "Spa to include Cosmetologists (Hair, Nails, Face) & Massage Therapists Licensed in TX" will require a separate specific use permit.
- Section 3: THAT, any person, firm, or corporation violating any of the provisions of this Ordinance, as read together with the Unified Development Code and accompanying map thereto, shall be guilty of a misdemeanor and upon final conviction therefore shall be fined in a sum not to exceed Two Thousand Dollars (\$2,000.00). Each and every day such

Section 4: THAT, the City Secretary is hereby authorized and directed to cause publication of the descriptive caption and penalty clause hereof as an alternative method of publication provided by law.
