## E. PERSONS TO BE HEARD

This is a time for the public to address the City Council on any subject. However, the Texas Open Meetings Act prohibits the City Council from discussing issues which the public has not been given seventy-two (72) hours' notice. #### F. CONSENT

The next order of business was for the City Council to consider the consent agenda items, which were deemed to need little or no discussion, and were acted upon as one business item.

- 3. Consider a resolution rejecting the bid from North Texas Contracting for the construction of the Mount Gilead Road Shared Use Path, and authorizing the City Manager to rebid the project on behalf of the City of Keller, Texas.
  - A motion was made by Council Member Eric Schmidt, seconded by Council Member Tag Green, to approve Resolution No. 3964 rejecting the bid from North Texas Contracting for the construction of the Mount Gilead Road Shared Use Path, and authorizing the City Manager to rebid the project on behalf of the City of Keller, Texas. The motion carried unanimously.
- 4. Consider a resolution approving an agreement for professional services with Kimley-Horn of Fort Worth, Texas, for the purpose of providing design and engineering services for the Old Town Keller Phase II Project; and authorizing the City Manager to execute all contract documents relating thereto on behalf of the City of Keller, Texas.

Station RR2, LLC., applicant. Panther City Industries, LLC., owner. (UDC-17-0033)

Ms. Trina Zais, Director of Public Services and Economic Development, gave a presentation relating to a request for a resolution approving a variance to the City of Keller Unified Development Code, Article 8, Zoning Districts, Development Standards, Tree Preservation, Section 8.03 - OTK (Old Town Keller) and Section 8.09 - Attached Wall Signs, for The Station Patio Icehouse, at 111 West Vine Street.

The applicants were present and addressed the City Council.

A motion was made by Council Member Tag Green, seconded by Council Member Chris Whatley, to approve Resolution No. 3967 approving a variance to the City of Keller Unified Development Code, Article 8, Zoning Districts, Development Standards, Tree Preservation, Section 8.03 - OTK (Old Town Keller) and Section 8.09 - Attached Wall Signs, for The Station Patio Icehouse, located on approximately 0.17-acre of land on the southeast corner of the intersection of West Vine Street and Lamar Street, being Lot 1R, Block 4, Original Town Keller Addition, at 111 West Vine Street, zoned OTK (Old Town Keller) with the following conditions:

- 1. A variance for a total of seven (7) attached signs on a single building shall be allowed.
- 2. A variance for the one hundred (100) square-foot "The Station" sign and the sixty-six (66) square-foot Station Patio Icehouse with train sign to exceed the

maximum allowed forty (40) square feet, as shown on "Exhibit A" shall be allowed

3. A variance for the one hundred (100) square-foot "The Station" sign to be taller than the roof, up to four (4) feet shall be allowed.

The motion carried unanimously by the following vote:

Consider a resolution approving a variance to the City of Keller Unified Development Code, Article 8, Zoning Districts, Development Standards, Tree Preservation, Section 8.08 Landscape Requirements, for Keller ISD Center for Advanced Learning, located on approximately 50.60 acres of land bounded on the north by North Tarrant Parkway, on the east by Willis Lane, on the south by Bursey Road, and on the west by Whitley Road, at 305 North Tarrant Parkway, being Lot 1, Block A of the K.I.S.D. Bursey Road Addition, and zoned PD-SF-8.4 (Planned Development-Single Family Residential-8,400 square foot lots). Billy Kidd, Keller Independent School District, property owner. Sangeetha Karthik, Corgan & Associates, architect/applicant. (UDC-17-0032)

Mr. Billy Kidd, Keller ISD, addressed the City Council regarding the proposal.

A motion was made by Council Member Armin Mizani, seconded by Mayor Pro Tem Debbie Bryan, to approve Resolution No. 3968 approving a variance to the City of Keller Unified Development Code, Article 8, Zoning Districts, Development Standards, Tree Preservation, Section 8.08 Landscape Requirements, for Keller ISD Center for Advanced Learning, located on approximately 50.60 acres of land bounded on the north by North Tarrant Parkway, on the east by Willis Lane, on the south by Bursey Road, and on the west by Whitley Road, at 305 North Tarrant Parkway, being Lot 1, Block A of the K.I.S.D. Bursey Road Addition, and zoned PD-SF-8.4 (Planned Development-Single Family Residential-8,400 square foot lots) with the following variance:

1. The variance to Section 8.08 to omit a landscape island and instead plant a minimum of two (2) trees with a minimum four inch (4") caliper adjacent to where the landscape island would be required within six (6) months shall be allowed.
