SEALED PROPOSALS addressed to the City Council of the City of Keller, Texas, will be received at the Keller City Hall until 2:00 pm on January 18, 2018, for the purpose of furnishing all supervision, labor, materials, and equipment and the performing of all work required in the construction of a 10' wide bike/pedestrian trail and other improvements incidental thereto; at which time and place the proposals will be publicly opened and read aloud and retained by the City for tabulation, checking and evaluation.

BIDS shall be submitted in sealed envelopes upon the blank Bid Form in the Contract Documents booklet. The entire Contract Documents booklet must be returned in a sealed envelope with the following forms filled out and signed (if necessary): Bid Form, Experience Record, Equipment Schedule, Disadvantaged Business Enterprises Form, Conflict of Interest Questionnaire, Local Government Officer Conflicts Disclosure Statement, Non-Collusion Statement, Vendor Compliance to State Law form, Contractor Compliance to Texas Sales Tax Code form and all additional forms included in the project manual. The Bid Bond for five (5%) percent of the total bid must be included in the sealed envelope with the bid. The sealed envelope shall be marked "Sealed Documents for: City of Keller, Mt. Gilead Road

Shared Use Path Project - DO NOT OPEN UNTIL 2:00 p.m. on January 18, 2018, at which time bids will be opened publicly and read. Financial Statements and Liabilities and Net Worth Forms may be included in a separate sealed envelope within the overall bid package.

Plans and contract documents may be examined without charge at the Keller City Hall, 1100 Bear Creek Parkway, Keller, TX 76244. Copies of such instruments may be obtained from the office of Neel-Schaffer, Inc. at 2501 Ave. J, Suite 120, Arlington, TX 76006 upon a non-refundable deposit of \$75.00 per set (half scale) made out to Neel-Schaffer, Inc. A non-mandatory pre-bid conference will be held at 2:00 pm on Thursday, January 11, 2018, at the Keller City Hall, 1100 Bear Creek Parkway, Room 106. Representatives of the Owner and Engineer will be present to discuss the project. Engineer will distribute to prospective bidders of record such Addenda as Engineer considers necessary in response to discussions or inquiries arising at the conference. The cutoff time for questions is Tuesday, January 16, 2018 at 2:00 pm.

In case of ambiguity or lack of clearness in stating proposal prices, the Owner reserves the right to adopt the most advantageous construction thereof, or to reject any or all bids. No bid may be withdrawn within sixty (60) days after date on which bids are opened.
