RESOLUTION NO. 3979

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE BID FROM NORTH TEXAS CONTRACTING, IN THE AMOUNT OF \$533.734.00, FOR THE CONSTRUCTION OF THE MT. GILEAD ROAD SHARED USE PATH, FOR THE PARKS AND RECREATION DEPARTMENT, AND FURTHER AUTHORIZES THE CITY MANAGER TO EXECUTE ALL DOCUMENTS RELATING THERETO, ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, it has been determined by the City Council of the City of Keller, Texas that it is in the best interest of the health, safety, and general welfare of the citizens of the City of Keller to implement a shared use path along Mt. Gilead Road to meet the needs of the citizens; and

WHEREAS, in 2015 the City of Keller was selected to receive a Local Project Advanced Funding Agreement, or grant, through the Texas Department of Transportation (TxDOT) for a shared use trail; and

WHEREAS, the shared use trail will add a 3,084 linear feet, 10-foot wide trail section along the north side of Mt. Gilead Road from Bourland Road to Woodborough Lane; and

WHEREAS, an RFP for Construction Services was advertised in accordance with State Law, and 6 bids were received on January 18, 2018, and North Texas Contracting was the lowest bidder at \$533,734.00; and

WHEREAS, Neel-Shaffer, the grant administrator, vetted the construction company and deemed them a satisfactory company to complete the project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2:	THAT, the City Council of the City of Keller,
	Texas, hereby approves the bid from North
	Texas Contracting, in the amount of
	\$533.734.00, for the construction of the Mt.
	Gilead Road shared use path, for the Parks and
	Recreation Department, and further authorizes
	the City Manager to execute all documents
	relating thereto, on behalf of the City of
	Keller, Texas.

Section 3: THAT, the cost for the City of Keller's contract with North Texas Contracting shall be paid through TxDot Funding in the amount of \$481,058.00 with a \$163,095.00 City match from the Trail Expansion project in the Parks System Capital Improvement Program Fund. Funds for the project were provided by the Keller Development Corporation fund.
