11		Keller to request a Specific Use Permit (SUP-17-0015), which has been reviewed by

13	WHEREAS,	notice of a public hearing before the Planning and Zoning Commission was sent to	
14		real property owners within three hundred	
15		feet (300') of the property herein described at least ten (10) days before such hearing;

18		general circulation in Keller at least fifteen (15) days before such hearing; and	
19	MUEDEAC	public hearings to issue a Specific Use	
20	WHEREAS,	Permit on the property herein described were	
21		held before both the Planning and Zoning Commission and the City Council, and the	
22		Planning and Zoning Commission has heretofore made a recommendation to approve	
23		the Specific Use Permit; and

25		Specific Use Permit herein effectuated furthers the purpose of zoning as set forth	
26		in the Unified Development Code and is in the best interest of the citizens of the

3 4	Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
5 6 7 8 9 10 11 12 13 14 15 16 17 18 19 20	Section 2: THAT, in accordance with the Unified Development Code, the City Council of the City of Keller, Texas hereby authorizes approval of a Specific Use Permit (SUP) for Andy's Frozen Custard, a single story 2,909 square-foot drive-thru restaurant, located on a 1.14-acre lot, on the north side of Keller Parkway (FM1709), approximately two hundred sixty feet (260') east of the Pate- Orr Road and Keller Parkway (FM1709) intersection, being Lot 3R-1R5, Block 8, Bluebonnet Trails Addition, at 951 Keller Parkway (FM1709), and zoned TC (Town Center), in the City of Keller, Tarrant County, Texas, with the proposal attached hereto as Exhibit "A", and incorporated herein, as if fully set forth with the following conditions: The condition for Andy's Frozen Custard to operate a drive-thru restaurant shall be allowed. The variance for the building to be less than six thousand (6,000) square feet shall be allowed.
21 22 23 24 25 26 27 28	Section 3: THAT, any person, firm, or corporation violating any of the provisions of this Ordinance, as read together with the Unified Development Code and accompanying map thereto, shall be guilty of a misdemeanor and upon final conviction therefore shall be fined in a sum not to exceed Two Thousand Dollars (\$2,000.00). Each and every day such violation continues shall constitute a separate offense and shall be punishable as such hereunder.
