## ORDINANCE NO. 1885

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING A SPECIFIC USE PERMIT (SUP) FOR JASON'S DELI; A SINGLE STORY 9,000 SQUARE-FOOT RESTAURANT WITH DRIVE-THRU, LOCATED ON A 1.58-ACRE LOT, ON THE SOUTH SIDE OF KELLER PARKWAY (FM1709), APPROXIMATELY FOUR HUNDRED SEVENTY FEET (470') WEST OF THE KELLER SMITHFIELD SOUTH AND KELLER PARKWAY (FM1709) INTERSECTION, BEING LOT 3, BLOCK E, KELLER TOWN CENTER ADDITION, AT 1400 KELLER PARKWAY (FM1709), AND ZONED TC (TOWN CENTER), IN THE CITY OF KELLER, TARRANT COUNTY, TEXAS; PROVIDING A PENALTY; AND AUTHORIZING PUBLICATION.

WHEREAS, Bomac Partners, LTD or assigns (Trinity Partners), applicant. Pinpoint Bear Creek Land Holding, LLC, owner; have submitted an application to the City of Keller to request a Specific Use Permit (SUP-18-0004), which has been reviewed by the City Staff; and

WHEREAS, notice of a public hearing before the Planning and Zoning Commission was sent to real property owners within three hundred feet (300') of the property herein described at least ten (10) days before such hearing; and

WHEREAS, notice of a public hearing before the City Council was published in a newspaper of general circulation in Keller at least fifteen (15) days before such hearing; and

WHEREAS, public hearings to issue a Specific Use Permit on the property herein described were held before both the Planning and Zoning Commission and the City Council, and the Planning and Zoning Commission has heretofore made a recommendation to approve the Specific Use Permit; and

WHEREAS, the City Council is of the opinion that the Specific Use Permit herein effectuated furthers the purpose of zoning as set forth in the Unified Development Code and is in the best interest of the citizens of the City of Keller.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: THAT, in accordance with the Development Code, the City Council of the City of Keller, Texas hereby authorizes approval of a Specific Use Permit (SUP) to allow Jason's a single story 9,000 square-foot restaurant with drive-thru, located on a 1.58acre lot, on the south side of Keller Parkway (FM1709), approximately four hundred seventy feet (470') west of the Keller Smithfield Keller Parkway and (FM1709) intersection, being Lot 3, Block E, Keller Town Center Addition, at 1400 Keller Parkway (FM1709), and zoned TC (Town Center), in the City of Keller, Tarrant County, Texas, with the proposal attached hereto as Exhibit "A", and incorporated herein, as if fully set forth with the following condition:
  - 1. A Specific Use Permit for Jason's Deli, a single story 9,000 square-foot restaurant with drive-thru, within the TC (Town Center) zoning district shall be allowed.

This condition for this SUP is specific to this business. Any new similar type business would require a new SUP application.

Section 3: THAT, any person, firm, or corporation violating any of the provisions of this Ordinance, as read together with the Unified Development Code and accompanying map thereto, shall be quilty of a misdemeanor and upon final conviction therefore shall be fined in a sum not to exceed Two Thousand Dollars (\$2,000.00). Each and every day such violation continues shall constitute separate offense and shall be punishable as such hereunder.

Section 4:	THAT, the City Secretary is hereby authorized			
	and directed to cause publication of the			
	descriptive caption and penalty clause hereof			
	as an alternative method of publication			
	provided by law.
