Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the site plan for Hibernia National Bank, a proposed 7,285-square foot building to be constructed, located on a 1.3691-acre lot on the southeast corner of Keller Parkway (FM 1709) and South Main Street (U.S. Highway 377), being Lot 1, Block A, Hibernia-Keller Addition, and zoned R-OTK (Retail-Old Town Keller Overlay), is hereby approved, attached hereto, and incorporated herein, as if fully set forth, with the following conditions:

- The maximum number of parking spaces 1. between landscaped islands shall increased from twelve (12) spaces to fourteen (14) spaces along the southern portion of the proposed site, in order to preserve an existing tree.
- 2. The vertical sign on the west facade shall be allowed to be 10.5 feet in height with halo-lit letters.
