I am against the proposal brought forward by the members of Northwood Church to rezone the property.



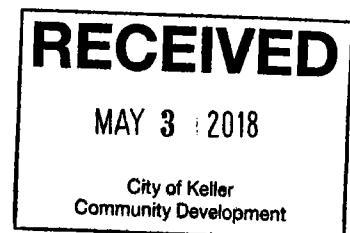


