

RESOLUTION NO. 4010

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE COMPETITIVE SEALED PROPOSAL FOR THE WALL PRICE KELLER ROAD IMPROVEMENTS PROJECT, FROM RAGLE, INC., OF BEDFORD, TEXAS, FOR THE PUBLIC WORKS DEPARTMENT, IN THE AMOUNT OF \$1,089,522.00; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL CONTRACT DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, it has been determined by the City Council of the City of Keller, Texas, that it is in the best interest of the health, safety and general welfare of the citizens of the City of Keller, Texas, to design and construct the Wall Price Keller Road Improvements project; and

WHEREAS, it has been determined by the City Council of the City of Keller, Texas that the Competitive Sealed Proposal method provides the best value for the Wall Price Keller Road Improvements project; and

WHEREAS, the two (2) sealed proposals received on May 1, 2018 have been reviewed by staff, and it is determined that the proposal from Ragle, Inc. of Bedford, Texas, in the amount of \$1,089,522.00 provides the best value.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby approves the proposal for the Wall Price Keller Road Improvements Project, from Ragle, Inc., of Bedford, Texas, for the Public Works Department, in the amount of \$1,089,522.00; and further authorizes the City Manager to execute all contract documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of said project shall be paid from the Street System Capital Improvement Program Fund, in the amount of \$1,089,522.00 with funding provided by the General Fund and Street Maintenance Sales Tax Fund.

Section 4: THAT, this resolution shall be effective upon its adoption.
