## ORDINANCE NO. 1890

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING A SPECIFIC USE PERMIT (SUP) FOR BLISS NAIL BOUTIQUE, A PROPOSED "SPA TO INCLUDE COSMETOLOGISTS (HAIR, NAILS, FACE) & MASSAGE THERAPISTS LICENSED IN TX", LOCATED IN THE EXISTING KELLER PLACE ADDITION, TO EXPAND AN ADDITIONAL 1,300 SQUARE-FEET IN A 11,900 SQUARE-FOOT MULTITENANT RETAIL BUILDING, ON A 0.273-ACRE LOT LOCATED ON THE EAST SIDE OF RUFE SNOW DRIVE, 427 FEET SOUTH OF NORTH TARRANT PARKWAY, AT 2041 RUFE SNOW DRIVE, SUITE 315, BEING LOT 4, BLOCK A, KELLER PLACE ADDITION AND ZONED R (RETAIL), IN THE CITY OF KELLER, TARRANT COUNTY, TEXAS; PROVIDING A PENALTY; AND AUTHORIZING PUBLICATION.

- WHEREAS, Ken Nguyen, applicant; Whitestone Reit Operating Partnership, LLC, owner; have submitted an application to the City of Keller to request a Specific Use Permit (SUP-18-0012), which has been reviewed by the City Staff; and
- WHEREAS, notice of a public hearing before the Planning and Zoning Commission was sent to real property owners within three hundred feet (300') of the property herein described at least ten (10) days before such hearing; and
- WHEREAS, notice of a public hearing before the City Council was published in a newspaper of general circulation in Keller at least fifteen (15) days before such hearing; and
- WHEREAS, public hearings to issue a Specific Use Permit on the property herein described were held before both the Planning and Zoning Commission and the City Council, and the Planning and Zoning Commission has heretofore made a recommendation to approve the Specific Use Permit; and
- WHEREAS, the City Council is of the opinion that the Specific Use Permit herein effectuated furthers the purpose of zoning as set forth in the Unified Development Code and is in the best interest of the citizens of the City of Keller.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: accordance THAT, in with the Unified Development Code, the City Council of the City of Keller, Texas hereby authorizes approval of a Specific Use Permit (SUP) to Bliss Nail proposed "Spa Boutique, а to include Cosmetologists (Hair, Nails, Face) & Massage Therapists Licensed in TX", located in the existing Keller Place Addition, to expand an additional 1,300 square-feet in a 11,900 square-foot multitenant retail building, on a 0.273-acre lot on the east side of Rufe Snow 427 feet south of North Tarrant Drive, Parkway, at 2041 Rufe Snow Drive, Suite 315, being Lot 4, Block A, Keller Place Addition and zoned R (Retail)), in the City of Keller, Tarrant County, Texas, with the proposal attached hereto as Exhibit ``Α″, and incorporated herein, as if fully set forth with the following condition:
  - 1. A Specific Use Permit for Bliss Nail Boutique, a proposed "Spa to include Cosmetologists (Hair, Nails, Face) & Massage Therapists Licensed in TX", to expand an additional 1,300 square-feet in an existing 11,900 square-foot multitenant retail building at 2041 Rufe Snow Drive, Suite 315, shall be allowed. This specific use permit is specific to Bliss Nail Boutique. Any other "Spa to include Cosmetologists (Hair, Nails, Face) & Massage Therapists Licensed in TX" will require a separate specific use permit.
- Section 3: THAT, any person, firm, or corporation violating any of the provisions of this Ordinance, as read together with the Unified Development Code and accompanying map thereto, shall be guilty of a misdemeanor and upon final conviction therefore shall be fined in

a sum not to exceed Two Thousand Dollars (\$2,000.00). Each and every day such violation continues shall constitute a separate offense and shall be punishable as such hereunder.

Section 4: THAT, the City Secretary is hereby authorized and directed to cause publication of the descriptive caption and penalty clause hereof as an alternative method of publication provided by law.
