Dear Mark:

Please allow this letter of understanding to serve as official acceptance of the following dental rates for an effective date of October 1, 2018. Thank you for choosing Cigna and we appreciate the opportunity to continue to be a partner with the City of Keller.

The final rates for the DPPO Option are:

Employee Only	\$32.55	(119)
Employee & Family	\$90.48	(135)

The rates are based on an assumed enrollment of 254 subscribers and an assumed annual premium of \$193,059

Cigna is also providing an additional one-time \$10,000 wellness credit allowance for a total of \$20,000 to the City of Keller to be used during the 2018-19 plan year.

The rates for the dental plan will be guaranteed for 12 months. There is a rate cap of +7.5% for the 10/1/19 dental renewal and a cap of +6.5% for the 10/1/20 dental renewal.
