Re: Turquoise Gypsy Justification for Requested Variance

To Whom It May Concern:


Businesses in the heart of Old Town Keller, on the west side of Hwy 377 vary rarely use the front entrance to their business. Since the Beautification of Old Town Keller, the main focus has been directed to the back of the businesses. Turquoise Gypsy has a very small location, sandwiched in a strip of businesses from Ann Gibson Insurance to Bottle Cap Alley. There is no building space on the back of 156 South Main to install a sign that would be visible from the walkway to parking lot. Turquoise Gypsy name is located on the back door, but not readable from the walkway or parking lot. Numerous businesses in Old Town have signage located on the backside of their businesses and Turquoise Gypsy should be allowed the same privilege.

A sandwich sign is permitted according to the Keller permit department. Turquoise Gypsy currently has a sandwich sign display but due to the number of children that play in the area, it rarely remains upright and has been used as a toy.

The signage located on the fence (Norma Steward's property) was installed permanently in November 2017 and was never intended to be a "temporary" sign as referred to in the City Ordinance Violation letter. The sign presents no danger to foot traffic/children due to being securely installed on the fence. Since the sign was installed on the property owner's fence facing the parking lot and not on the building, I didn't realize that a permit would be required from the city. The sign in question was planned and crafted with the aesthetics of the uniqueness of Turquoise Gypsy and the art displayed in Old Town. No complaints have been voiced from my customers or surrounding businesses since the sign has been installed.

The Beautification project severely impacted my business due to the massive amount and duration of construction. Recovering from the financial loss has been a slow process. Installing the sign in the back has brought new customers into the boutique. They say, "We saw your sign and didn't realize you were here". They are shocked when I respond that I have been in this location for almost four years. Removing the sign from my small business will mean a loss of traffic/customers and dollars spent in Old Town Keller. Turquoise Gypsy is my sole source of income and I would like to grow my business and "Keep it in Keller".

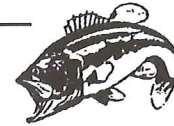
