AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING A SPECIFIC USE PERMIT (SUP) TO ALLOW THE USE OF A PRIVATE SCHOOL, LOCATED IN MULTIPLE BUILDINGS TOTALING APPROXIMATELY 10,630 SQUARE FEET, CONSISTING OF APPROXIMATELY 0.912-ACRES OF PROPERTY, LOCATED ON THE NORTH SIDE OF PECAN STREET, APPROXIMATELY 250 FEET NORTH EAST OF THE INTERSECTION OF SOUTH MAIN STREET (US 377) AND PECAN STREET, BEING LOT 7R AND LOT 9, BLOCK 7, KELLER, CITY ADDITION, ZONED OTK (OLD TOWN KELLER), LOCATED AT 133 AND 121 PECAN STREET. IN THE CITY OF KELLER, TARRANT COUNTY, TEXAS; PROVIDING A PENALTY; AND AUTHORIZING PUBLICATION.

- WHEREAS, Trinity Preparatory Academy, applicant, and Zadok International Ministries Church, Inc., owner; have submitted an application to the City of Keller to request a Specific Use Permit (SUP-18-0040), which has been reviewed by the City Staff; and
- WHEREAS, notice of a public hearing before the Planning and Zoning Commission was sent to real property owners within three hundred feet (300') of the property herein described at least ten (10) days before such hearing; and
- WHEREAS, notice of a public hearing before the City Council was published in a newspaper of general circulation in Keller at least fifteen (15) days before such hearing; and
- WHEREAS, public hearings to issue a Specific Use Permit on the property herein described were held before both the Planning and Zoning Commission and the City Council, and the Planning and Zoning Commission has heretofore made a recommendation to deny the Specific Use Permit; and
- WHEREAS, the City Council is of the opinion that the Specific Use Permit herein effectuated furthers the purpose of zoning as set forth in the Unified Development Code and is in the best interest of the citizens of the City of Keller.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: THAT, in accordance with the Unified Development Code, the City Council of the City of Keller, Texas hereby authorizes approval of a Specific Use Permit (SUP) to allow the use of a Private School, located in multiple buildings totaling approximately 10,630 square feet, consisting of approximately 0.912-acres of property, side of located on the north Pecan approximately 250 feet north east of the intersection of South Main Street (US 377) and Pecan Street, being Lot 7R and Lot 9, Block 7, Keller, City Addition, zoned OTK (Old Town Keller), located at 133 and 121 Pecan Street, in the City of Keller, Tarrant County, Texas, with the proposal attached hereto as Exhibit "A", and incorporated herein, as if fully set forth with the following condition:
  - 1. The Specific Use Permit for Trinity Preparatory Academy to operate a Private School, shall be considered.

This condition for this SUP is specific to this business. Any new similar type business or Private School (would require a new SUP application.

- Section 3: THAT, any person, firm, or corporation violating any of the provisions of this Ordinance, as read together with the Unified Development Code and accompanying map thereto, shall be guilty of a misdemeanor and upon final conviction therefore shall be fined in a sum not to exceed Two Thousand Dollars (\$2,000.00). Each and every day such violation continues shall constitute a separate offense and shall be punishable as such hereunder.
- Section 4: THAT, the City Secretary is hereby authorized and directed to cause publication of the descriptive caption and penalty clause hereof as an alternative method of publication provided by law.
