A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE PRIMARY BID FROM FERGUSON WATERWORKS, OF MCKINNEY, TEXAS, WITH AWARD BY THE LOWEST TOTAL AMOUNT BID OF \$242,266.21, AND APPROVING THE SECONDARY BID FROM CORE & MAIN, LP OF RICHLAND HILLS, TEXAS, IN THE AMOUNT OF \$296,311.76 WITH AWARD BY THE GREATEST PROPOSED DISCOUNTS ON LIST ITEMS, FOR THE PURCHASE OF WATER AND SEWER LINE PARTS, FOR THE WATER AND WASTEWATER DIVISION OF THE PUBLIC WORKS DEPARTMENT; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL PURCHASE DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, a request for sealed bids for the purchase of water and sewer line parts, for the Water and Wastewater Division of the Public Works Department was duly advertised in accordance with State law, and said bids were received, opened, and read aloud at 3:00 p.m., on February 26, 2019; and

WHEREAS, the Fiscal Year 2018-19 Annual Budget provides for the purchase of water and sewer line parts, for the Water and Wastewater Division of the Public Works Department; and

WHEREAS, the proposed agreement shall last one (1) year with the option to extend said agreement for an additional four (4) one (1) year periods; and

WHEREAS, funding for additional one (1) year periods is contingent upon budget approval by the City Council for water and sewer parts; and

WHEREAS, two (2) qualifying sealed bids were received from Ferguson Waterworks, of McKinney, Texas, and Core & Main, LP, of Richland Hills, Texas.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby approves the primary bid from Ferguson Waterworks, of McKinney, Texas, with award by the

lowest total amount bid of \$242,266.21, and Core & Main, LP in the amount of \$296,311.76 for the greatest proposed list-price discounts, for the purchase of water and sewer line parts, for the Water and Wastewater Division of the Public Works Department; and further authorizes the City Manager to execute all purchase documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, in the event the vendor with the lowest total amount bid price is disqualified or otherwise unable to provide the water and sewer parts, the vendor with the next lowest total amount bid price shall automatically be awarded the total bid.

Section 4: THAT, the cost of said purchase of water and sewer line parts, for the Water and Wastewater Division of the Public Works Department shall be paid from the Water and Wastewater Fund, budgeted therefor.
