

RESOLUTION NO. 4122

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE BID FROM PEACHTREE CONSTRUCTION, OF FORT WORTH, TEXAS, FOR THE 2019 ANNUAL STREET MAINTENANCE PROJECT, IN THE AMOUNT OF \$1,417,130.65, FOR THE PUBLIC WORKS DEPARTMENT, AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL CONTRACT DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, the City of Keller has an annual Capital Improvements Program (CIP) to rehabilitate residential streets that have deteriorated past the point of utilizing normal maintenance activities to restore the street to its desired condition; and

WHEREAS, voters have approved a  $\frac{1}{4}$ -cent sales tax and a Street Improvement Fund was established to receive the funds generated by the sales tax; and

WHEREAS, the total cost for the base bid plus one (1) additive alternate bid item is within the budget of \$1,451,609.00 for this project; and

WHEREAS, the three (3) sealed bids received on May 8, 2019 have been reviewed by staff, and it is determined that the bid from Peachtree Construction, of Fort Worth, Texas, in the amount of \$1,417,130.65 is the lowest and most responsible bid.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby approves the bid for the 2019 Annual Street Maintenance Project, from Peachtree Construction, of Fort Worth, Texas, for the Public Works Department, in the amount of \$1,417,130.65 for the Base Bid plus one (1) Alternate Bid item; and further authorizes the City Manager to execute all contract documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the project is included in the Street System Capital Improvement Program Fund with funding provided by the Street Maintenance Fund.

Section 4: THAT, this resolution shall be effective upon its adoption.
