

RESOLUTION NO. 4145

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING AN AGREEMENT WITH MHB CONSTRUCTION, INC, OF FORT WORTH, TEXAS, FOR THE CONSTRUCTION OF THE WHITLEY ROAD SAFE ROUTES TO SCHOOL PROGRAM, FOR THE PARKS AND RECREATION DEPARTMENT, IN AN AMOUNT OF \$1,114,217.41; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL CONTRACT DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, In June of 2017 the City of Keller was awarded Transportation Set Aside Program funding the Whitley Road Safe Routes to School project. The construction costs came in at \$1,114,217.41 of which \$775,039 is being funded with Federal funds administered by TxDOT, \$55,171 by the State of Texas, and a City contribution of \$284,007.41.

WHEREAS, it has been determined by the City Council of the City of Keller, Texas that it is in the best interest of the health, safety, and general welfare of the citizens of the City of Keller to add .75 miles of a 10' wide trail along Whitley Road from Edenderry Drive to Rapp Rd then continuing along Rapp Rd to Willis Lane; and

WHEREAS, City staff recommends selecting MHB Construction, Inc, of Ft. Worth, Texas for the construction of the trail in the amount of \$1,114,217.41; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby approves an Agreement to MHB Construction, Inc of Fort Worth, Texas; for the purpose of constructing the Whitley Road Safe Routes to School Project, in the amount of \$1,114,217.41; and further authorizes the City Manager to execute all contract documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of said work shall be paid in the Parks System Capital Improvement Fund with funding provided by the Keller Development Corporation Fund.

Section 4: THAT, this resolution shall be effective upon its adoption.
