

RESOLUTION NO. 4158

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPOINTING MEMBERS TO THE KELLER ANIMAL SHELTER ADVISORY COMMITTEE, AS PROVIDED FOR IN SECTION 823.005 OF THE TEXAS HEALTH AND SAFETY CODE, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Texas State law under the Health and Safety Code of Animals, Chapter 823. Animal Shelters, Section 823.005, requires the City of Keller, Texas to appoint an advisory committee to assist in complying with the requirements of the State Health and Safety Code, Title 10. Health and Safety of Animals; and

WHEREAS, the City Council of the City of Keller, Texas, desires to comply with the requirements of Chapter 823, Section 823.005, of the State Health and Safety Code; and

WHEREAS, the Committee is to consist of at least one (1) licensed veterinarian, one (1) county or municipal official, one (1) person whose duties include the daily operation of an animal shelter, and one (1) representative from an animal welfare organization.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby appoints the following members to the Keller Animal Shelter Advisory Committee:

Jarrold Greenwood - Municipal Official, Public Works Director, Town of Westlake

Michelle Watson - Animal Control Officer, City of Keller

Dr. Susan Boeving DVM - Licensed Veterinarian, Southlake Crossing Animal Clinic

Nelda Corbell - Animal Welfare Organization, Humane Society of North Texas

Section 3: THAT, the Animal Shelter Advisory Committee shall hereby appoint from its members a Chairperson to said Committee.

Section 4: THAT, this resolution shall become effective immediately upon its passage and approval.

Section 5: THAT, the City Council of the City of Keller, Texas charges the Keller Animal Shelter Advisory Committee to assist in complying with the requirements of Chapter 823 of the State Health and Safety Code, Health and Safety of Animals.

Section 6: THAT, the members of the Keller Animal Shelter Advisory Committee shall serve an indefinite term until a vacancy occurs.
