RESOLUTION NO. 4169

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE PURCHASE OF A REPLACEMENT INDOOR POOL SLIDE, FOR THE KELLER POINTE RECREATION AND AQUATIC CENTER, IN THE TOTAL AMOUNT OF \$286,672.00; FROM SPLASHTACULAR WATERSLIDES AND WATERPARK ATTRACTIONS OF PAOLA, KANSAS; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL PURCHASE DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

- WHEREAS, the City Council of the City of Keller, Texas, has deemed it necessary and in the best interest of the citizens of the City of Keller to replace the existing Indoor Pool Slide at The Keller Pointe Recreation and Aquatic Center; and
- WHEREAS, the Fiscal Year 2019-20 Annual Budget provides for the purchase of said replacement system for The Keller Pointe Recreation and Aquatic Center; and
- WHEREAS, the purchase from SplashTacular Waterslides and Waterpark Attractions, of Paola, Kansas, program has been determined to be the most responsible method of purchasing therefor.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: THAT, the City Council of the City of Keller, Texas hereby approves the purchase of a replacement Indoor Pool Slide, in the total amount of \$286,672.00, for The Keller Pointe Recreation and Aquatic Center, from SplashTacular Waterslides and Waterpark Attractions, of Paola, Kansas; and further authorizes the City Manager to execute all purchase documents relating thereto on behalf of the City of Keller, Texas.
- Section 3: THAT, the cost of said purchase of replacement Indoor Pool Slide shall be paid from the General Government Capital Improvement Project Fund with funding from The Keller Pointe Recreation and Aquatic Center Fund in the amount of \$286,672.00, budgeted therefor.
