

RESOLUTION NO. 4165

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE PURCHASE OF ONE (1) REPLACEMENT VAC-CON HYDRO-EXCAVATION AND VACUUM TRUCK IN THE AMOUNT OF \$370,986.75 FROM HOUSTON FREIGHTLINER OF HOUSTON, TEXAS, THROUGH THE HOUSTON-GALVESTON AREA COUNCIL PURCHASING COOPERATIVE; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL PURCHASE DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, the City Council of the City of Keller, Texas, has deemed it necessary and in the best interest of the citizens of the City of Keller to purchase one (1) replacement Vac-Con hydro-excavation and vacuum truck, for the City of Keller; and

WHEREAS, the Fiscal Year 2019-20 Water & Wastewater Utility Fund and Fleet Replacement Fund budgets provide for the purchase of said vehicle in the amount of \$377,000; and

WHEREAS, the purchase from Houston Freightliner of Houston, Texas through the Houston-Galveston Area Council Purchasing Cooperative has been determined to be the lowest and most responsible method of purchasing therefor.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas, hereby approves the purchase of one (1) replacement Vac-Con hydro-excavation and vacuum truck from Houston Freightliner of Houston, Texas, through the Houston-Galveston Area Council Purchasing Cooperative in the amount of \$370,986.75; and further authorizes the City Manager to execute all purchase documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of said purchase of one (1) replacement Vac-Con hydro-excavation and vacuum truck, and related equipment, shall be paid from the Water & Wastewater Utility Fund and Fleet

Replacement Fund, in the amount of \$377,000 budgeted therefor.

AND IT IS SO RESOLVED.
