A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE BID FROM FLOW LINE UTILITIES, INC, OF DALLAS, TEXAS, IN THE AMOUNT OF \$119,141.00, FOR IMPROVEMENTS TO BEAR CREEK PARK, FOR THE PARKS AND RECREATION DEPARTMENT, AND FURTHER AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS RELATING THERETO, ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, it has been determined by the City Council of the City of Keller, Texas that it is in the best interest of the health, safety, and general welfare of the citizens of the City of Keller to provide improvements to Bear Creek Park to meet the needs of the citizens; and

WHEREAS, the engineering firm of Thomas Hoover Engineering, LLC., was used to develop a design approved by the Keller Development Corporation and issued for competitive bidding in August, 2019; and,

WHEREAS, bids were advertised in accordance with State Law, and 8 bids were received on September 10, 2019, and Flow Line Utilities, Inc., of Dallas, Texas, was the lowest bidder meeting specifications at \$119,141.00; and

WHEREAS, the engineering firm of Thomas Hoover Engineering, LLC, and City Staff, vetted the construction company and deemed them a satisfactory company to complete the project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas, hereby approves the bid from Flow Line Utilities, Inc., in the amount of \$119,141.00, for improvements to Bear Creek Park, for the Parks and Recreation Department, and further authorizes the City Manager to execute all documents relating thereto, on behalf of the City of Keller, Texas.

Section 3: THAT, the cost for the City of Keller's contract with Flow Line Utilities, Inc. shall be paid in the amount of \$119,141.00 by the Parks System Capital Improvement Program Fund. Funds for the project have been provided by the Keller Development Corporation fund and will be provided by the Parks Capital Improvement Program fund thru interest income which will require a future budget amendment to allocate to the project.
