

RESOLUTION NO. 4182

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE PURCHASE OF ONE (1) REPLACEMENT KUBOTA TRACK LOADER IN THE NET PURCHASE AMOUNT OF \$22,894.90 FROM ZIMMERER KUBOTA & EQUIPMENT, INC., OF FORT WORTH, TEXAS, THROUGH THE BUYBOARD COOPERATIVE PURCHASING PROGRAM, FOR THE PARKS AND RECREATION DEPARTMENT; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL PURCHASE DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, the City Council of the City of Keller, Texas, has deemed it necessary and in the best interest of the citizens of the City of Keller to replace a track loader for the Parks and Recreation Department; and

WHEREAS, the Fiscal Year 2019-20 Keller Development Corporation Annual Budget provided for the purchase of said replacement track loader; and

WHEREAS, the purchase from Zimmerer Kubota & Equipment, Inc., of Fort Worth, Texas, through the BuyBoard Cooperative Purchasing Program, has been determined to be the lowest and most responsible method of purchasing therefor.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas, hereby approves the purchase of one (1) replacement Kubota Track Loader, from Zimmerer Kubota & Equipment Inc., of Fort Worth, Texas, through the Buyboard Cooperative Purchasing Program, for the Parks and Recreation Department, for total equipment purchase cost of \$76,394.90 and trade-in of old equipment of \$53,500, for a net purchase cost of \$22,894.90; and further authorizes the City Manager to execute all purchase documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of said purchase of one (1) replacement Kubota Track Loader, in the net purchase amount of \$22,894.90, for the Parks and Recreation Department, shall be paid from the Keller Development Corporation Fund, budgeted therefor.
