

RESOLUTION NO. 4227

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING AMENDMENT NO 1 TO A PROFESSIONAL SERVICES CONTRACT WITH TEAGUE NALL AND PERKINS, FOR THE PURPOSE OF PROVIDING ADDITIONAL ENGINEERING SERVICES AND PUBLIC MEETINGS, RELATING TO THE RECONSTRUCTION OF JOHNSON ROAD FROM HALLELUJAH TRAIL TO RHONDA ROAD, IN THE AMOUNT OF \$95,000.00; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL CONTRACT DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, the City has an existing \$714,100.00, professional services contract with Teague Nall and Perkins, of Fort Worth, Texas, approved by Resolution No. 4065, to provide engineering services for said project; and

WHEREAS, the City requested Teague Nall and Perkins, of Fort Worth, Texas to do work beyond the original scope of work.

WHEREAS, the additional roadway design and public involvement for said project amounts to a total of \$95,000.00.

WHEREAS, the terms and conditions set forth in the Fee Amendment Request No. 1 is attached hereto as Exhibit "A".

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby approves an Amendment to the Professional Services contract with Teague Nall and Perkins, of Fort Worth, Texas be used to perform the necessary roadway designs and public involvement for said project, in a total amount of \$95,000.00; as set forth in Amendment No .1 and further authorizes the City Manager to execute all contract documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of said Amendment for the additional Professional Services will be funded from Street Capital Improvement Program with funding provided by the General fund, the Street and Sidewalk Improvement fund, the Roadway Impact Fee fund and the SWIFT bonds.

Section 4: THAT, this resolution shall be effective upon its adoption.
