The use is harmonious and compatible with surrounding existing uses or proposed uses; The activities requested by the applicant are normally associated with the permitted uses in the base district; The nature of the use is reasonable and appropriate in the immediate area; Any negative impact on the surrounding area has been mitigated; and That any additional conditions specified ensure that the intent of the district purposes are being upheld.
