# A. CALL TO ORDER – Mayor Pat McGrail

Mayor Pat McGrail called the Special Council Meeting to order at 7:02 P.M.

Mr. Ed Yrisarri, 1445 Melody Lane, expressed his support of Community Waste Disposal for the Citywide Solid Waste Collection and Recycling Services.

### C. WORK SESSION

1. <u>Discuss final proposals from Frontier Waste Solutions and Community Waste Disposal relating to the Request for Qualifications and Proposals for Citywide Solid Waste Collection and Recycling Services.</u>

Mrs. Sarah Hensley, Administrative Services Manager, gave a presentation relating to the Request for Qualifications and Proposals for Citywide Solid Waste Collection and Recycling Services. The City Council discussed the best and final offers from both companies.

Mr. John Gustafson, President & CEO, Frontier Waste Solutions, and Mr. Greg Roemer, President & CEO, Community Waste Disposal, were both present to address the City Council.

Discussion was held by the City Council. The City Council directed staff to move forward with a contract with Community Waste Disposal (CWD). Mayor Pro Tem Sean Hicks was not in favor of the selection of CWD.

### **D. NEW BUSINESS**

1. <u>Consider a resolution authorizing the City Manager to execute an Interlocal Cooperation Agreement with Tarrant County for Municipal Direct Expense Funding.</u>

City Manager Mark Hafner addressed the City Council regarding the agreement.

A motion was made by Mayor Pat McGrail, seconded by Council Member Sheri Almond, to approve Resolution No. 4245 authorizing the City Manager to execute an Interlocal Cooperation Agreement with Tarrant County for Municipal Direct Expense Funding. The motion carried unanimously.
