A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING CHANGE ORDER NO. 5 TO THE CONTRACT FOR CONSTRUCTION OF THE WATER SYSTEM CAPITAL IMPROVEMENT PLAN – PHASE 1 PROJECT WITH NORTH TEXAS CONTRACTING INC. OF KELLER, TEXAS, IN THE AMOUNT OF \$100,000.00; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL CONTRACT DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

- WHEREAS, on November 5, 2019 the City Council of the City of Keller approved Resolution No. 4181 authorizing Contract No. 19-86 with North Texas Contracting, Inc. for construction of the Water System Capital Improvement Plan Phase 1 project (Project); and
- WHEREAS, Contract 19-86 included a City-estimate of contingency needs in the amount of \$100,000.00 for modifications and additional work encountered which could not be foreseen prior to construction of the Project; and
- WHEREAS, construction of the Project is approximately half complete and the original allowance has been used to pay for Change Orders Nos. 1 4 for modifications and additional work encountered to-date during construction; and
- WHEREAS, it is essential to increase the allowance for future modifications and additional work that may be encountered as construction of the Project continues; and
- WHEREAS, the allowance provided in Contract No. 19-86 with North Texas Contracting, Inc. for construction of the Project is recommended to be increased in the amount of \$100,000.00 thereby increasing the amount of Contract No. 19-86 to \$2,767,155.00 as set forth in Change Order No. 5, attached hereto as Exhibit "A".

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: THAT, Change Order No. 5 to Contract No. 19-86 with North Texas Contracting, Inc. for construction of the Water System Capital Improvement Plan Phase 1 project, in the amount of \$100,000.00 thereby increasing the amount of Contract No. 19-86 to \$2,767,155.00,
